1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated here under:

**1.1 Technical Criteria:**

**1.1.1** The bidder should be a **Manufacturer of 'Mobile crane'** or 'authorized Dealer / Distributor' of manufacturer for the same.

**1.1.2** The bidder should have executed the order(s) for supply of Heavy Earth Moving Vehicle, during the preceding seven (07) years prior to date of Techno-commercial bid opening in any of the following manner:

(a) Executed value not less than Rs 687 Lakhs in a Single Contract.

OR

(b) Executed value not less than Rs. 430 Lakhs in Two Contracts each.

(c) Executed value not less than Rs. 344 Lakhs in Three Contracts each.

**NOTES:**

1. The word "executed" means the bidder should have achieved the criterion specified in the Qualifying Requirements, even if the Order is not completed/closed.

2. In case of order under execution as on date of techno commercial bid opening, the value of the order executed till such date will be considered provided the same is certified by the employer.

3. The dealer/distributor should be especially authorized by the manufacturer for participating in this bid.

4. For arriving at the executed value of order specified above, basic amount only shall be considered. In case order is inclusive of taxes, bidder should provide the break - up of basic value and taxes".

5. **Heavy Earth Moving Vehicle** means Back-hoe loader and/or Mobile Crane and /or Truck mount

ed crane and/or rough terrain crane and/or Dozer and / or Pay Loader and/or Tele-handler and/or Tyre-Handler and/or Excavator and/or Motor Grader.

## **1.2 Financial Criteria:**

1.2.1 The Average Annual Turnover of the Bidder, should not be less than **859 lakhs (Rupees Eight Crore Fifty-Nine Lakh only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

(a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

(b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
