OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. **4.1.1 (a) Proven Experience**

Further, the Bidder must have supplied at-least two (2) Sets of **Blades/Vanes (Out of two**

**sets minimum one set should be Blades)** for Siemens make Gas Turbine or its equivalent design of minimum 100 MW ISO rating, which should have completed successful operation of at least "one Hot Gas Path Inspection (HGPI) or major overhaul" having minimum 15,000 Equivalent Overhauling Hours (EOH) prior to the techno-commercial bid opening date.

**4.1.1 (b) Specific Plant related Technology and capability**

Bidder must either himself possess or have access to the necessary technology for manufacturing of **Blades** of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for **Faridabad** Gas Power Station having ISO rating of **159 MW** at Turbine Inlet Temp (TIT) of 1060 Deg C.

The Bidder at his option can also outsource any of the activities required for manufacturing of above **Blades** subject to the condition that the chosen outsource agency by the bidder also has the necessary technology for manufacturing of **Blades** of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for **Faridabad** Gas Power Station having ISO rating of **159 MW** at Turbine Inlet Temp (TIT) of 1060 Deg C.

**4.1.1 (c)** The Bidder should have executed order for 'Supply of Gas Turbine and/or Gas Turbine Components' within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner:

(i) **One (1)** order having executed value not less than **Rs.898 Lakh**

**OR**

(ii) **Two (2)** orders having executed value not less than **Rs.561 Lakh each**

**OR**

(iii) **Three (3)** orders having executed value not less than **Rs.449 Lakh each**

**4.1.2 Route-2 [Meeting Criterion 4.1.2 (a) & 4.1.2 (b)]**

**4.1.2 (a)** The Bidder can be licensee or Authorized Agent of Gas Turbine original equipment manufacturer (OEM) or its equivalent design. In such case, the bidder can be considered qualified based on the experience of the Principal who meets the requirements mentioned at para 4.1.1 (a) and 4.1.1 (b) above.

**4.1.2 (b)** The "Bidder or its Principal" should have executed order for 'Supply of Gas Turbine and/or Gas Turbine Components' within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner

i. **One (1)** order having executed value not less than **Rs.898 Lakh**

**OR**

ii. **Two (2)** orders having executed value not less than **Rs.561 Lakh each**

**OR**

iii. **Three (3)** orders having executed value not less than **Rs.449 Lakh each**

**Notes for 4.1.1 & 4.1.2**

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is

not completed/closed.

2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.
4. NTPC has the right to access the capability and capacity of the bidder for carrying out the manufacturing of required Gas Turbine **Rotor Blades** of V 94.2 machines of its **Faridabad** plant in case of bidder meets the above qualifying requirements through any route.

#### **4.2 Financial Criteria:**

4.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 11.23 Cr (Rupees Eleven Crores Twenty-Three lakh only)** during the preceding three (3) completed financial years prior to the date of Techno-Commercial bid opening.

4.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 4.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 4.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

4.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

i. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company

4.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### **Notes for 4.2:**

1. Other income shall not be considered for arriving at annual turnover.
2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of
