OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 4. NTPC has the right to access the capability and capacity of the bidder for carrying out the manufacturing of required Gas Turbine Compressor disc/wheel of V 94.2 machines of its Faridabad plant in case of bidder meets the above qualifying requirement through any route.

#### 1.2 Financial Criteria:

- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno C ommercial bid opening are not available, the financial results certified by a practicing Chartered

Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate fro m

practicing Chartered Accountant certifying its financial parameters, the audited results of three con

secutive financial years preceding the last financial year shall be considered for evaluating the fina ncial parameters. Further, a Certificate would be required from the CEO/CFO as per the format encl osed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno- Commercial bid opening and the Certificate from the practicing Chartered A ccountant certifying the financial parameters is not available.

- i. Other income shall not be considered for arriving at annual
- ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in voque.
- iii. In case of any executed value submitted by the bidder is in foreign currency, Bill Selling Exchan ge Rate established by State Bank of India as on the date of Techno-Commercial bid opening shall be used
