EXPRESSION OF INTEREST FOR DEPLOYMENT OF E-VEHICLES

Expression of Interest (hereinafter EOI) is invited for following work: -

Name of Work : **Deployment of E-Vehicle Model - Mahindra XUV 400 model EL PRO FC - Battery 39.4 Kwh - Charger 7.2 Kw – E (Air Conditioned) {with commercial/taxi registration} for 12-hour basis per day for NTPC Chatti Bariatu Coal Mining Project (herein after referred as CBCMP) and Kerandari Coal Mining Project (herein after referred as KDCMP), Hazaribagh.**

The EOI, elaborated hereinafter, comprises three parts viz Part- A (Applicable only for CBCMP EOIs), Part-B (Applicable only for KDCMP EOIs) and General Condition common for both CBCMP and KDCMP EOIs.

PART-A (CBCMP)

- 1) No of Vehicles required - 2 Nos.
- 2) **E-Vehicle Model** - Mahindra XUV 400 model EL PRO FC - Battery 39.4 Kwh - Charger 7.2 Kw – E (Air Conditioned) {with commercial registration}
- 3) Only **PAFs of CBCMP** are requested to submit their Expression of Interest (EOI) for deployment of new e-vehicle as per procedures prescribed in this EOI within given time lines. Any other EOI received shall not be considered.

PART-B (KDCMP)

- 1) No of Vehicles required – 5 Nos.
- 2) **E-Vehicle Model** - Mahindra XUV 400 model EL PRO FC - Battery 39.4 Kwh - Charger 7.2 Kw – E (Air Conditioned) {with commercial registration}
- 3) Any individual prospective PAF of KDCMP only are hereby requested to submit their Expression of Interest (EOI) for deployment of new e-vehicle as per procedures prescribed in this EOI within given time lines. Any other EOI received shall not be considered.

GENERAL (COMMON) CONDITIONS:

1) **Period of Work** : Two Years from Date of Start as per PO.

2) **EMD:** Not applicable

3) **Critical Dates:**

Last Date for receipt of EOI : upto 24.03.2025 till 14:30 Hrs
Date and time for opening of EOI : On 24.03.2025 from 15:00 Hrs onwards.

4) One E-vehicle will be deployed from one PAF only.

5) The PAFs, if happen to be affected by both CBCMP and KDCMP, they shall submit the above details pertaining to CBCMP and KDCMP separately in the same application.

6) **QUALIFYING REQUIREMENTS(QR)**

- a) For CBCMP – The EOI applicant must be a PAF (Land + Homestead, Land and Homestead oustees) of CBCMP.
- b) For KDCMP – The EOI applicant must be a PAF (Land + Homestead, Land and Homestead oustees) of KDCMP.

In support of meeting above, EOI applicant shall submit following documents:

- a) PAF Category Undertaking
- b) Land documents
- c) Land Payment proof.
- d) Certified copy of Family Tree
- e) PAN Card
- f) Adhar Card
- g) Address Proof
- h) Any other documents as required by NTPC

7) **PRIORITY LIST**

All EOIs received will be examined to establish the fulfillment of above QR. EOIs who meets above QR criteria for CBCMP and KDCMP, a list of PAFs shall be prepared for each CBCMP and KDCMP. Priority list of the EOIs who meets above QR criteria shall be prepared as per the following criteria for CBCMP and KDCMP separately:

- i. **(Land + Homestead) oustees** assumed as **Category-A** would be considered at **Ist priority** (weightage on the basis of acreage of land acquired).
- ii. **Homestead oustees** assumed as **Category-B** would be considered at **IInd priority** and
- iii. **Land oustees** assumed as **Category-C** would be considered at **IIIrd priority** (weightage on the basis of acreage of land acquired).
- iv. Vehicle applicants who are not engaged through direct / indirect employment by the project / Station will be preferred for the deployment of vehicle, subject to above priority.
- v. However, if PAF falls in same category, the preference shall be as per the date of birth of vehicle owner according to PAN/DL/Aadhar card/10th certificate. Older date of birth

- (oldest owner) shall be given first preference. The applicants who are already engaged in running contract, their names shall be considered for award of any contract against subject empanelment only after expiry of the existing running contract.
- vi. If the numbers of eligible applicants meeting the EOI requirements are more than the number of vehicles required, then the balance applicants shall be empaneled for three years from the date of approval of empanelment, to meet any future requirement of the vehicle at Stations/Projects. If required, NTPC may extend the validity of the period of empanelment.
 - vii. The PAF who has been awarded a contract for hiring vehicle shall be given least priority irrespective of category for consecutive contract of vehicle hiring.

8) **OTHER CONDITIONS**

A) Brief Terms and Conditions of Deployment are mentioned below:

- i. **E-Vehicle Model - Mahindra XUV 400 model EL PRO FC - Battery 39.4 Kwh - Charger 7.2 Kw – E (Air Conditioned)**
- ii. **Vehicle should possess TAXI/COMMERCIAL REGISTRATION.**
- iii. **Deployment charges per month including driver: Rs.46000/- excl GST.**
- iv. The period of deployment shall be 2 Years extendable for further 3 Years based on mutual consent and subject to satisfactory condition of vehicle as certified by EIC.
- v. All other terms and condition of contract shall be as per detailed SCOPE OF WORK AND TERMS AND CONDITIONS FOR DEPLOYMENT OF E-VEHICLE and as per NTPC GCC for Civil works.

B) The applicant would purchase new E-vehicle and deploy within 21 days of issue of Letter of Intent and shall submit their application with an undertaking to purchase new vehicle.

C) In case any applicant on issuance of LOI/PO fails to deploy the vehicle within the specified time period, the next applicant in the priority list shall be considered for deployment of vehicle. The applicant who has failed to deploy the vehicle shall be considered in the last after exhaustion of all the remaining applicant in the priority list.

D) The number of vehicle requirement may change for each project. In case of increase/decrease, the deployment shall be done as per PRIORITY LIST of each project respectively.

E) The EOI document is available online. A complete set of EOI Documents may be downloaded by any interested Bidder from the NTPC tender website <https://eprocurementpc.nic.in>.

F) Mode of Submission of EOI: The applicants are required to submit duly filled Application form along with relevant documents at <https://eprocurementpc.nic.in> on or before the last date and time mentioned above. No hardcopy documents received shall be considered for evaluation.

G) Issuance / Downloading of Application document by any applicant shall not construe that such applicant is considered to be qualified.

H) NTPC reserves the right to reject any or all application or cancel/withdraw the EOI for the

subject package without assigning any reason whatsoever and in such case no applicant **shall** have any claim arising out of such action.

I) It is expected that the applicants have gone through EOI and its attachments/annexures in detail.
