- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - **5.** Bidder has to mandatorily fill the Annexure-12 (QR summary sheet) in support of reference doc uments for meeting QR and upload the same along with the technical bid in Technical Cover. (R efer ITB clause 26 for more details).
- **6.** The Techno-Commercial Bid should not contain any price content entry. In case, the Techno-Commercial Bid is found to contain any price content, such bid shall be outrightly rejected.
- **7.** The PBG details mentioned in the GEM bid are indicative only and are not fully in line with the t ender requirements due to limitations in the portal. Hence, the value, duration and other applic able terms & conditions of PBG to be submitted shall be in line with the ATC document.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
