- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

## 1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirement s stipulated hereunder:

## 1.1: Technical Criteria:

- 1.1.1 The bidder is a manufacturer of steel cord conveyor belt.
- 1.1.2 The bidder has executed order(s) for supply of 'steel cord conveyor belt of width 20 00 mm or higher and strength 1700 kN/Mtr. or above.
- 1.1.3 The bidder should have executed supply order(s) for steel cord conveyor belts within preceding 07 (seven) years prior to the date of Techno- commercial bid opening in a ny of the following manner:
- i) Single executed order of value not less than Rs. 264 Lakhs.

OR

ii) Two executed orders of value not less than Rs. 165 Lakhs each

OR

iii) Three executed orders of value not less than Rs. 132 Lakhs each

#### Notes for Technical Criteria:

- The word "Executed" mentioned above means that the bidder should have achie
  ved the criteria specified above, even if the total order is started earlier and/or is n
  ot completed/closed.
- In case of orders under execution, the value of the order executed prior to the da te of Techno-Commercial bid opening duly certified by bidder's client shall be consi dered acceptable.
- 3. For arriving at the executed value of the order specified above, basic amount only shall be considered. In case order is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / IS
   O certificate /MDCC/ any other statutory document as a proof of being manufacture

#### 1.2: Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 329 Lakh (Ru pees Three Crore Twenty -Nine Lakh only) during the preceding three (3) completed financial years **prior to the** date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover require ments at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the I ast day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alo ne entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for sub stantiation of its qualification.
- -Copies of the unaudited unconsolidated financial statements of the bidder along with copi es of the Audited consolidated financial statements of its Holding Company.
- -A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form p art of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 1.2:

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to the mas per Companies Act of India, in voque.
- 3. Net worth means the sum total of the paid up share capital and free reserves. Free res erve means all reserves credited out of the profits and share premium account but doe s not include reserves credited out of the revaluation of the assets, write back of depre ciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

### Notes-

- 1. Only PO submitted along with bid shall be considered for evaluation of Qualifying requirement.
- 2. EMD BG to be submitted only in NTPC format(Annexure-I). EMD BG in any other format i ncluding GeM format is not acceptable and bid is liable to be rejected during tendering sta ge. EMD BG should reach NTPC Raipur office within 10 working days from date of bid opening date.
- 3. Loading of material at vendor's side, transportation upto NTPC site Store shall be on vendor's account and no extra payment shall be done for loading and transportation of material.
- 4. Bidder has to upload self attested copy of NTPC technical data sheet as given in GeM bi dding document under Compliance to BOQ tab towards acceptance & compliance of technical specifications.

- 5. The sellers who participate in current Tender are deemed to have fully accepted all Terms & Conditions, Technical Specifications, Data Sheets, Drawings, Quality Plans and inspection requirement, Buyer Added Bid Specific Terms and Conditions given in Bidding Documents, read in conjunction with Amendment(s)/ Clarification(s)/ Addenda/ Errata (if any) issued by the Buyer prior to opening of Techno-Commercial Bids, and the same are supposed to have been taken into consideration while making their Techno-Commercial Bid & Price Bid. Further it is construed that no deviation has been taken by the seller in this regard. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the su bject package without assigning any reason whatsoever and in such case no bidder/i ntending bidder shall have any claim arising out of such action. Further, NTPC reserve s right to amend any bid/tender conditions through appropriate CORRIGENDUM publis hed in the portal at any time. NTPC also reserves the right to extend/change the bidding schedule through publishing necessary CORRIGENDUM in the portal if the situation demand so at any time. The corrigendum as decided by NTPC and deemed fit would be published in the portal as per provisions therein. This prevails over the relevant provisions elsewhere in the bid document. The corrigendum/amendment as published/posted in the portal will be binding on Bidders and it will be assumed that the information contained therein will have been taken into account by the Bidder in its bid. Bidder s are advised to regularly check the tender regarding posting of Amendments/Corrige ndum, if any.
- 7. The requirement of Average Annual Turnover (AATO) for MSE -SC/ST & MSE-Women is not required (QR cl no. 1.2- Financial Criteria).
- 8. **Matching of IP addresses**: IP address functionality has been introduced in GeM portal. The objective of this feature is to identify collusion activities between sellers by capturing their IP addresses. During technical evaluation stage of a tender, if common IP address is found between sellers, then all such bids are liable for rejection.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
