In case it is established that Bidder has provided any false information in pursuance of the aforesaid Claus e, while competing for this contract, then its bid shall be rejected, and EMD/bid security shall be forfeited.

In case of a successful bidder, if it is established that the Bidder has not complied with terms of aforesaid C lause, during execution of contract, this would be considered as fraudulent practice as mentioned in para 5 .1 (j) of "Policy for Debarment from Business Dealings" and shall be dealt accordingly.
