To avail MSE benefit in respect of EMD exemption and purchase preference, Bidde should be a manufacturer of offered product. Traders are excluded from purview o MSE benefit.

EMD exemptions as per GeM GTC shall be applicable.

9. How to Fill Price Bid on GEM: Under the subject Rate contract, the Bidde s are required to quote "Accepted % of base value" against the Tender Price (in luding GST).

- (i) If a Bidder quotes 110% against the field "Accepted % of base valu ", then it will be considered that the Bidder has offered 10% Premi m on the tendered Price.
- (ii) Similarly, if a Bidder quotes 90% against the field "Accepted % of b se value", then it will be considered that the Bidder has offered 10% discount on the Tendered Price.

Further, Bidder's to note that the offered Premium / Discount mentioned y them in the Bid shall be uniformly applicable on Estimated Unit Rate for each line item (inclusive of GST) under the Rate Contract.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buye may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
