1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### **1.0 QUALIFYING REQUIREMENT**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated her eunder:

### 1. Technical Criteria :

### 1.1.:-

(a) The bidder should have a valid RDSO certificate for manufacturing of "Railway wagons including hoppe r wagons" as specified in IR specification G105, with annual capacity of at least 600 nos. wagons/annum.

(b) The bidder should have executed Order(s) for supply of 'bottom discharge type wagon(s)', within the p receding seven (07) years prior to the date of Techno commercial bid opening.

### **Notes for Technical Criteria:**

1.Copy of Purchase Order(s) and Completion certificate /Invoice(s)/ Receipt(s)/E-way Bills- to be submitted as a proof of meeting technical criteria1.1.(b).

2.Copy of valid RDSO certificate to be submitted as a proof of meeting technical criteria 1.1.(a).

### 2. FINANCIAL CRITERIA :

**1.2.1** The Average Annual Turnover of the Bidder, should not be less than **Rs. 2993 Lakh (Rupees Twe nty nine Crore and ninety three Lakh only)** during the preceding three (3) completed financial years p rior to the date of Techno- Commercial bid opening.

**1.2.2.** In case the bidder does not satisfy the financial criteria, stipulated at Cl.1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provi ded that the net worth of such Holding Company as on the last day of the preceding financial year is at lea st equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder w ould be required to furnish along with its Techno- Commercial bid, a Letter of Undertaking from the Holdin g Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging un conditional and irrevocable financial support for the execution of the Contract by the bidder in case of awar d.

1.2.3. Net worth of the Bidder should not be less than 100% (hundred percent) of it s paid-up share capital as on the last day of the preceding Financial year reckoned f rom the date of Techno-commercial bid opening. In case the Bidder meets the requirement o f Net Worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of it s holding companies wherever applicable, the Net Worth of the Bidder and its Subsidiary(ies) and/or Hold ing Company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than n 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined) = [(X1 + X2 + X3) / (Y1 + Y2 + Y3)] X 100%

Where X1, X2, X3 are individual Net worth which should not be less than **75%** (Seventy-five percenta ge) of the respective paid-up share capitals and Y1, Y2, Y3 are individual paid up share capitals.

**1.2.4** In cases where audited results for the last preceding financial year as on the date of Techno-Comm ercial bid opening are not available, the financial results certified by a practicing Chartered Accountant sha II be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid open ing and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## Notes for Clause 2 above:

- (i) **Other income** shall not be considered for arriving at annual turnover figures.
- (ii) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as p er Companies Act of India.

(iii)Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means a II reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any d ebit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
