3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1.0 QUALIFYING REQUIREMENT (QR)

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

## **1.1 TECHNICAL CRITERIA**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

### **1.1 Technical Criteria :**

#### **1.01 Route-1 [Meeting Criterion 1.01 (a), 1.01(b) ]**

##### **1.01 (a) Proven Experience**

The Bidder should be the 'Original Equipment Manufacturer (OEM) of Siemens make Gas Turbine/manufacturer of Siemens make Gas Turbine sheet metal hot path components or its equivalent design & have already supplied at-least two (2) Nos. of the said components of Silo type for Siemens make Gas Turbine or its equivalent design of minimum 100 MW ISO rating, which should have satisfactorily completed one Hot Gas Path Inspection or major overhaul ( minimum 15,000 EOH)) prior to the technological bid opening date.

### **AND**

#### **1.01 (b) Specific Plant related Technology and capability**

Bidder must either himself possess or have access to the necessary technology for manufacturing sheet metal components of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for Dadri Gas Power Station having ISO rating of 1

42.42 MW at Turbine Inlet Temp (TIT) of 1060 Deg C.

The Bidder at his option can also outsource any of the activities required for manufacturing of the above sheet metal components subject

to the condition that the chosen outsource agency by the bidder also has the necessary technology for manufacturing of the said components of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for Dadri Gas Power Station having ISO rating of 142.42 MW at Turbine Inlet Temp (TIT) of 1060 Deg C.

#### **1.02 Route-2 [Meeting Criterion 1.02 ]**

1.02 The Bidder can be licensee or Authorized Agent of Gas Turbine original equipment manufacturer (OEM) or its equivalent design. In such case, the bidder can be considered qualified based on the experience

of the Principal who meets the requirements mentioned at para 1.01(a) and 1.01(b) above.

#### **Notes for 1.01 & 1.02:**

NTPC has the right to access the capability and capacity of the bidder for carrying out the manufacturing of required sheet metal components of V 94.2 machines of its Dadri plant in case of bidder meets the above qualifying requirement through any route.



## 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 16.01 Cr (Rupees Sixteen Crore One lakh only)** during the preceding three (3) completed financial years prior to the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 Net worth of the Bidder should not be less than 100% (hundred percent) of its paid-up share capital as on the last day of the preceding Financial year reckoned from the date of Techno-commercial bid opening. In case the Bidder does not meet the Net worth criteria on its own, it can meet the requirements of Net worth based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of the Holding Companies, wherever applicable. In such a case, however the Net worth of the Bidder and its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of the Holding Companies, in combined manner should not be less than 100% of their total paid up share capital. However individually, their N

et worth should not be less than 75% of their respective paid-up share capital.

Net worth in combined manner shall be calculated as follows:

Net worth (combined)=  $[(X1 + X2 + X3) / (Y1 + Y2 + Y3)] \times 100$

Where X1, X2, X3 are individual Net worth which should not be less than 75% (Seventy-five percentage) of the respective paid-up share capitals and Y1, Y2, Y3

are individual paid up share capitals.

1.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- i. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- ii. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company

1.2.5 In cases where audited results for the last preceding financial year as on the date of Techno- Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters

ers. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## Notes for 1.2:

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid up share capital and free reserves. Free reserve means a reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
