Mode of Tendering: Limited tender

Background: W.P.(C) No. 2092 of 2025 filed for the work relating to “Dispatch of coal through RLS System at Banadag Railway Siding of Pakri Barwadih Coal Mining Project for a period of 15 months” pursuant to Notice Inviting Tender dated 26.12.2024 (Contract already awarded) is presently pending before the Hon'ble High Court of Jharkhand. Vide interim order dated 29.04.2025, the Hon'ble High Court of Jharkhand has restrained the awarded agency from executing the work till further orders.

Accordingly, the subject NIT is being processed through Limited Tender as a short-term measure, till the outcome of the W.P.(C) No. 2092 of 2025. It may be noted that the award of any work pursuant to this Limited Tender shall be provisional and subject to the final outcome of the said writ proceedings, so as to safeguard the legal position of the querist and avoid any unintended consequences.

- I. NTPC invites on-line bids on Single Stage Two Envelope Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforementioned package as per Scope of Work mentioned hereinafter.
- II. **Brief Scope of Work: Dispatch of coal through RLS System for a period of 5 months.**

Bidder may submit EMD (if applicable) in a sealed envelope separately offline along with other documents mentioned in the tender documents by the stipulated bid submission closing date and time at the address given below in accordance with the provisions set forth in the bidding documents, failing which, online bid shall be treated as nonresponsive and shall not be opened. **ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY/EMD SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.**
- V. **Subject Tender is floated on Limited Tender (LT) basis and vendors eligible to participate have been shortlisted and approved by Competent Authority as per Works & Procurement Policy of NTPC". Any Other Bidder(s) who is not shortlisted / approved by Competent Authority for this Bid shall not be considered and Bids of such Bidder(s) shall be summarily rejected during Technical Evaluation.**
- VI. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

- VII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the Gem Portal <https://gem.gov.in>. The Bidder would be required to register on the website <https://gem.gov.in>.

No Hard Copy of bidding documents shall be issued.

- VIII. Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- IX. Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- X. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- XI. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
