I. NTPC invites on-line bids on **Single Stage Two Envelope** Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders on **Open tender basis** for afore-mentioned package as per Scope of Work mentioned hereinafter.

II. Brief Scope of Work:

Deployment of Equipments on per ton basis for handling-rehandling of coal for Kerendari coal mining project for a period of 12 months. Further, brief scope of work includes as under:

- 1) Removal/Loading, Transportation, Unloading of coal from surface coal stock yard/crushed coal stock yard of Kerandari Coal Mining Project (KDCMP)
- 2) Deployment of suitable capacity Equipments like payloader, Hywa /Dumper/ Tipper to handle/shift the ROM coal from ROM coal stock yard to Hopper of 500TPH crusher or as per direction of EIC.
- 3) Movement of the Hywa /Dumper within the range (lead) of 1KM and shall be within the vicinity of KDCMP.
- 4) Equipments shall be available as and when required and as per direction of EIC to meet the NTPC requirement. Hywa / Dumper / Tipper must be hydraulically operated (Tail gate should not be manually operated).
- 5) Equipment's **maintenance** / required **consumables** / **Fuel** / **Spares** shall be in bidder scope.
- 6) Minimum loading and transportation envisaged in scope of work is 30,000 - 50,000 MT per months

Detailed Scope shall be as per Technical Specification / Terms of Reference.

III. NTPC intends to finance the aforesaid Package through Own Resources.

- VII. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- VIII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the Gem Portal [https://gem.gov.in.](https://gem.gov.in/) The Bidder would be required to register on the website.

No Hard Copy of bidding documents shall be issued.

- IX. Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard

before submission of their bids.

- X.** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- XI.** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- XII.** Downloading / Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- XIII.** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

Qualifying Requirements

1.0 Technical Criteria:

The Bidder must have experience of works (includes completed / ongoing contracts) of similar nature (as per the definition of similar nature works given below) within the preceding seven (07) years reckoned as on the date of Techno-Commercial Bid Opening with either of the following.

- (a) Single order with executed value not less than **Rs. 164 Lakh**
or
- (b) Two orders with executed value not less than **Rs 103 Lakh each**
or
- (c) Three orders with executed value not less than **Rs 82 Lakh each**

Notes for Clause 1.0:

- i. Similar work means either fulfilling the conditions of (a) or/and (b) or/and (c).
 - a. Handling of coal/ Soil/ Rocks/ Ash/ Stone/ Rejects or any Solid Mineral using Plant and Machinery equipment in mine or in any industry.
 - b. Deployment of Heavy Equipment's essentially comprising of Loader, Excavator, Tipper & Hywa in mine or in any industry.
 - c. Supply of material handling equipment like Crusher, Sizer etc.
- ii. The bidder should have achieved the above specified eligibility criteria during last seven (7) years as on date of Techno-commercial bid opening even if the contract has been started earlier and / or is not completed /closed.
- iii. Executed Value means basic value (excluding taxes) of the Purchase Order/Work Order/Agreement pertaining to work executed, as defined above. Where Purchase Order/Work Order/Agreement value is composite, the bidder shall give break-up of Composite PO value mentioning Basic Value, taxes etc.
- iv. In case the bidder has executed any reference work as a JV partner/consortium member, the experience of the bidder shall be considered equivalent to the executed value of work corresponding to value of work under the scope of bidder only as per the JV/Consortium Agreement/certified by owner/statutory auditor etc. (as applicable). In case bidder is not able to substantiate the above with documentary evidence, the experience of the bidder shall be considered in proportion to the bidder's equity participation as per JV/consortium agreement or other documentary evidence.

2.0 Financial Criteria of the Bidder:

- 2.1** The average annual turnover of the Bidder in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than **INR 205 lakhs (Indian Rupees Two Hundred and Five Lakh only).**

In case the Bidder does not satisfy the average annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements as above, provided that the Net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share

capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its techno-commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

2.2 In case the Bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the Bidder can be considered acceptable provided the Bidder further furnishes the following documents for substantiation of its qualification:

- (i) Copies of the unaudited unconsolidated financial statements of the Bidder along with copies of the audited consolidated financial statements of the Holding Company.
- (ii) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed with the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated financial statement of the Holding Company.

In case where audited results for the last financial year as on date of Techno Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for clause No. 2.0:

- (i) Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- (ii) Other income shall not be considered for arriving at annual turnover.
- (iii) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- (iv) The requirement of Average Annual Turnover (AATO) for MSE-SC/ST & MSE-Women is not required. Evaluation for these bidders shall be carried out based on only technical criteria mentioned in the QR

3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
