- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are

advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

## 1. Buyer Added Bid Specific ATC

#### 1.0 QUALIFYING REQUIREMENTS:

1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulat ed here under:

- **1.Technical Criteria:** For meeting requirement of 1.1 AND 1.2
- 1.1. The bidder should be a 'manufacturer/ authorized dealer' of IBR-certified valve(s) and shoul d have supplied actuator operated, IBR certified valve(s) of rating class 900 or above and si ze 50mm or above, within the preceding seven (07) years prior to the date of Techno- Commercial bid opening.
- 1.2 The bidder should have supplied Block Valves/Stop Valves/Gate Valves/Globe Valves/Control Valves/ Check Valves/ Butterfly Valves to any "Thermal Power Plant" and/or to any "Boiler Manufac turer" within the preceding seven (07) years prior to the date of Techno- Commercial bid opening in the following manner:
- A. One (1) order having executed value not less than Rs.105 Lakh

OR

B. Two (2) orders having executed value not less than Rs.65 Lakh each

OR

C. Three (3) orders having executed value not less than Rs.52 Lakh each

Notes for Technical Criteria:

i.The word "Executed" mentioned above means that the bidder should have achieved the criteria s pecified above, even if the total contract is started earlier and/or is not completed/closed.

ii.In case of orders under execution, the value of work executed prior to the date of Techno-Comme rcial bid opening duly certified by bidder's client shall be considered acceptable.

iii.For arriving at the executed value of work specified above, basic amount only shall be considere d. In case contract is inclusive of taxes, bidder should provide the break -up of basic value and taxe s.

#### 2. Financial Criteria:

- 2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 131 Lakh (Rupees One Crore and Thirty One Lakh only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 2.2 In case the bidder does not satisfy the financial criteria stipulated at Cl. 2.1 above on its own, it s Holding Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such a nevent, the bidder would be required to furnish along with its Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclose d in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 2.3 Net worth of bidder shall not be less than 100% of the bidder's paid up share capital as on the l ast day of the preceding financial year. In case the Bidder meets the requirement of Net worth base d on the strength of its Subsidiary(ies) and/or Holding company and/or Subsidiaries of its Holding C ompanies wherever applicable, the Net worth of the Bidder and its Subsidiary(ies) and/or Holding c ompany and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less th an 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid up share capitals. For Consortiums/Joint Ventures, wherever applicable, the Net worth of all consortium/ Joint Venture members in combined manner should not be less than 100% of their paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined)=(X1+X2+X3)/(Y1+Y2+Y3)x100 where X1, X2, X3 are individual net

worth which shall not be less than 75% of the respective paid up share capitals and Y1, Y2, Y3 are individual paid up share capitals.

2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity b asis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the biddin g documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 2.5 In cases where audited results for the last preceding financial year as on the date of Techno- Co mmercial bid opening are not available, the financial results certified by a practicing Chartered Acc ountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from pr acticing Chartered Accountant certifying its financial parameters, the audited results of three conse cutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclose d in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for Financial Criteria:

- 1.Other income shall not be considered for arriving at annual turnover.
- 2."Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per C ompanies Act of India, in vogue.
- .Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 1.MSE -SC/ST & MSE-Women bidders are exempted from meeting the Average Annual Turnover (AA TO) requirement of financial QR. Accordingly, for these bidders Evaluation shall be carried out only based on Technical Criteria of Qualification Requirements.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
