2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - (i) NTPC enlisted vendors for Contract Enlistment Group (Eligible Enlisted Vendor List For Contractor Enlistm ent for "MAINTENANCE OF CONVEYOR SYSTEM IN CHP FOR NN/EP BELT JOINT WORK. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
