4.0 Brief Scope of Work and other Specific details:

Supply, Installation, testing and commissioning of fresh air filtration systems with required modifications in Existing AHU to improve the Indoor Air Quality by reducing harmful pollutants.

5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

6.0 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

7.0 Qualifying Requirements for Bidders:

7.1 The bidder should have executed job of Supply, Installation and commissioning of air purification or air filtration systems or executed modifications/alterations involving air purification technologies in the existing Air Handling System comprising of AHUs & Ducts in India in the preceding Seven (7) years prior to the date of techno-commercial bid opening in any one of the following:

a) One (1) work having executed value not less than Rs. 54.21 Lakh

OR

b) Two (2) works having executed value not less than Rs. 33.88 Lakh each

OR

c) Three (3) works having executed value not less than Rs. 27.10 Lakh each

Note-1: The work "executed" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed / closed.

Note-2: In case of contracts under execution as on date of techno-commercial bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

Note-3: The above value of executed work is exclusive of applicable tax / GST.

7.2 The average annual turnover of the bidder, in the preceding three (3) financial years as on the date of techno-commercial bid opening shall not be less than Rs. 67.76 Lakh

Note:

(i) While computing the turnover other income shall not be considered.

(ii) In cases where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing

Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
