I. NTPC invites on-line bids on **Single Stage Two Envelope** Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders on **Open tender basis** for afore-mentioned package as per Scope of Work mentioned hereinafter.

II. Brief Scope of Work:

The coal handling plant (CHP) at PBCMP is ensuring a continuous supply of coal to RLS for onward dispatch of coal from Railways to various NTPC plants. The current system under owner CHP starts from TP-1 to TP-10, these steel structure requires regular monitoring and as part of its preservation, structure inspection and painting is being carried out as per standard schedule.

The specification defines the requirements for surface preparation and application of paints on external surfaces of structure, etc. The contractor is fully responsible for application of all paint materials, carrying out all the necessary arrangement like scaffolding, approach platform etc in compliance to safety norms for painting, coating, and lining on steel structure and piping surfaces, removal of scraps as per the tender requirement.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
