EOI for Empanelment of MSE-SC/ST and MSE-Women agencies for Transportation of Ash through Road from NTPC Sites

A) Introduction:

NTPC Limited generates more than 400 billion units of electricity per year through its power plant assets of coal, gas, hydel and renewable energy-based totaling approximately 80 GW capacity spread across the country. Furthermore, NTPC intends to reach a capacity of 130 GW by 2032. NTPC has been procuring Ash Transportation Services of approx. Rs.4500 Crores annually.

B) Intent of Expression of Interest

NTPC Ltd. is inviting Expression of Interest from MSE-SC/ST and MSE-Women agencies for Transportation of Ash through Road from NTPC Sites. The above category/classification of MSE Bidder shall be considered based on their **submitted Udyam Certificate verified online from UDYAM Portal. No other document will be referred for the same.**

C) Scope of Work:

The scope of activities would include the following:

The scope of work of NTPC tenders will generally include Transportation of ash through road from various NTPC plants to different destinations of Ash utilization Avenues such as Road Projects, Flyover Embankments, Mines, Shoreline Protection Structures, Dam Construction, or any other destination as per requirement, including work of excavation, Loading of ash from Ash Dyke/Ash Silo of NTPC thermal power plant(s) by mechanical means, Transporting ash in a closed container / dumpers (Covered with tarpaulin) as per CPCB guidelines, Unloading and stacking (if required) at various destinations as per the requirement of specific tenders and complying to statutory norms and government rules.

Suitable arrangements have to be made by the Agency for transportation of ash in an environmentally friendly manner. Agency has to ensure that no spillage of ash takes place during transportation. Ash is to be collected from NTPC plants as per availability on as-is-where-is basis. The Agency has to unload the ash throughout the stretch / length of road and other designated areas as indicated in the scope of work for specific tenders.

Quantity Measurements and Payment Criteria will be specified separately in the Tender against the specific requirements.
