# 1. Buyer Added Bid Specific ATC

The Bidder is required to quote **Total Lumpsum Price (including GST)** in Ge M Bid considering the BOQ as per ATC / Technical Specifications. Apart from GE M PO, NTPC shall also issue SAP PO for facilitating the payment with item wise p rice breakup of the final price as per ATC / Technical Specifications.

# 1. EMD

Bidder has to upload scanned copy / proof of the EMD along with online bid.

Any bid not accompanied by an acceptable bid security in a separate sealed en velope shall be rejected by the Employer as being non-responsive.

# Note: Submission of Bid Security is not required from Sellers exempte d from furnishing Bid Security as per GeM GTC

- 2. Buyer Added Bid Specific ATC
- 1. A complete set of documents have been enclosed in the GEM bid.

2. Terms and Conditions stipulated in ATC will supersede those in GeM GTC and STC in case of any conflicting provisions.

3. Bidders are required to submit the documents/bid as per the provisions menti oned in the tender documents.

4. SD (Security Deposit): SD shall be deducted @ 5% in each bill up to the ceilin g value of 5% of award value.

5. The Minimum Local content required is 60 % for Class-I local suppliers.

6. Eligibility condition for Participation: As per NIT and TS

7. Instructions for filling the Price Bid: As per ATC / Technical Specifications

8. Further, submission of bid by a bidder shall be considered as Bidder's confirm ation to accepting NO DEVIATION to all the provisions of the bidding documents and that the Bidder has confirmed compliance to the following:

ii) Compliance on the Integrity Pact, if applicable

iii) Compliance on Restriction on Procurement from a Bidder of a country which shares a land Border with India

9. MSEs seeking exemption/ benefits should enclose an attested/self-certified co py of registration certificate (**UDYAM**) as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs. In respe ct of bid for Services, the benefits to the participating Service Providers shall be applicable irrespective of product (Goods / Services) categories for which bidder is registered as MSE.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

# All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
