- B. The average annual turnover of the bidder in the preceding three (03) financial years as on the date of techno-commercial bid opening, shall not be less than Rs.48 Lakhs (Rupee Forty-Eight Lakhs)

- i) Other income shall not be considered for arriving at annual turnover.
