1.0 Technical Requirement:

1.1 The bidder shall possess valid Special Class/First Class boiler repair license issued by Directorate of Factories & Boilers, Govt. of West Bengal and submit along with bid.

The Bidder should submit an undertaking along with the bid that they will submit Special Class/First Class boiler repair license issued by Directorate of Factories & Boilers, Govt. of West Bengal within 15 days of issue of LOI.

- 1.2 The bidder should executed similar works during the last 07 (Seven) years of scheduled technical bid opening:
- a) One *similar* executed/completed work costing not less than the amount equal to ₹128.54 Lakh (exclusive of all taxes and duties)

"OR"

b) Two similar executed/completed works costing not less than the amount equal to ₹80.34 Lakhs each. (exclusive of all taxes and duties)

"OR"

c) Three similar executed/completed works costing not less than the amount equal to ₹64.27 Lakhs each. (exclusive of all taxes and duties)

2.0 Financial Requirement:

2.1 The average annual Turnover of the bidder, in the preceding three (3) financial years as on the date of techno-commercial bid opening, shall not be less than ₹160.67 lakhs (Indian Rupees One Hundred sixty lakhs sixty-seven thousand)

Note:

- (i) Values as per clause 1.2 and 2.1 shall be considered exclusive of taxes & duties.
- (ii) The word "Executed" means the bidder should have achieved the criterion specified in Qualifying Requirements, even if the total contract is not completed /closed. - (iii) The phrase "Similar Work(s)" means: Maintenance / Overhauling of boiler pressure parts with or without Boiler Rotary Equipment /Milling system in a thermal power Plant.
- (iv) In case where Audited results for the last Financial Year as on the date of Technical Bid Opening are not available the financial results certified by practicing chartered accountant shall be considered acceptable in case bidder is not able to submit the certificate from a practicing chartered accountant certifying its financial parameters the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Technical bid opening and the certificate from the practicing chartered Accountant certifying the financial parameters is not available
- (v) Other income shall not be considered for arriving at annual turnover.
- Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- 7.0 Notwithstanding anything stated above, the Employer reserves the right to assess the credentials/capabilities/capacity of the Bidder/ his collaborators / associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
 - The physical or any mode of assessment/verifications by Employer shall include but not be limited to the assessment/verifications of office/ facilities/ banker's/ submitted reference works in lieu of credentials. A negative determination of such assessment of credentials/capacity/capabilities may result in rejection of the bid.
- 8.0 The reference works whose details have been declared in their bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR). The Employer at its discretion may seek any clarification and/or documentary evidence only for the reference works as mentioned above. However, no change or substitution of the reference works by new/additional plant for conforming to the specified qualifying Requirement shall be sought, offered or permitted".



However in case if any condition specified in सामान्य नियम और शर्तै/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India, any bidder from a country which shares a land border with India any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
