### **1.0 DISCLAIMER**

- 1.1 NVVN reserves the right to not proceed further, to change the process or procedure of enlistment. It also reserves the right to reject any or all applications or cancel/withdraw the Enlistment process without assigning any reason whatsoever and in such case no applicant / bidder / intending bidder shall have any claim arising out of such action. It also reserves the right to decline to discuss further with any Applicant applying for Enlistment.

### **2.0 INTRODUCTION**

NTPC Vidyut Vyapar Nigam Ltd. (NVVN) was formed by NTPC Ltd in the year 2002, as its wholly owned subsidiary to tap the potential of power trading in the country. NVVN holds a highest Category 'I' power trading license as per latest CERC regulation. NVVN has foray in the field of Electric Mobility and Renewable Projects.

NVVN has already installed various solar project and to undertake development of subsequent Solar Power Projects, NVVN plans to enlist bidders meeting the specified Eligibility Criteria and willing to be associated with NVVN for its upcoming Solar Projects.

### **3.0 SCOPE OF WORK**

The scope for Rooftop Solar Project includes the following:

1. Design/ engineering, supply, transportation, unloading storage, installation, testing and commissioning of rooftop Solar Photo Voltaic Plant.
2. All associated electrical and civil works
3. Liaisoning with concerned authority for grid connectivity and approval for Net metering/net billing/ behind the meter connection.
4. Module cleaning system (wet method) including supply and installation of all accessories.
5. Remote monitoring with all hardware & software which will enable transfer of data pertaining to generation and weather to NVVN's centralised Solar Energy Data Monitoring platform.
6. Operation & maintenance of SPV Plant along with electrical equipment, consumables and spare parts for a period of Ten years from the date of completion of facility and PG test.

The scope for Ground Mounted Solar Project includes the following:

1. Design/ engineering, supply, transportation, unloading storage, installation, testing and commissioning of ground mounted Solar Photo Voltaic Plant.
2. Site-grading, clearing of vegetation, Topography survey, Geotechnical Investigation as per requirement.
3. Construction of Central Monitoring and Control Station with switchgear room, SCADA room, Storeroom, inverter room, Battery room with all electrical fitting and furniture, etc. as per project requirement.
4. All associated electrical and civil works required for interfacing with grid and evacuation of power.
5. Module cleaning system (wet or dry method) including supply and installation of all accessories.
6. Construction of approach road, pathways, peripheral boundary wall etc. as per specification.

7. SCADA system for remote monitoring and control of Inverters with all hardware & software which will enable transfer of data pertaining to generation and weather to NVVN's centralized Solar Energy Data Monitoring platform.
8. Operation & maintenance of SPV Plant along with electrical equipment, consumables and spare parts for a period of ten years from the date of completion of facility and PG test.
9. Supply of Mandatory spares.

#### **4.0 INFORMATION REQUIRED AS PART OF APPLICATION FOR ENLISTMENT**

- 4.1 Applicants are required to submit the duly filed application form as mentioned below along with their supporting Documents/Certificates in the Attachments enclosed in this document.

- 5.2 All costs incurred by Applicant for preparing and submitting the Application for Enlistment, in providing clarification or any other expenses whatsoever shall be borne by Applicants themselves, regardless of the conduct or outcome of the Enlistment process.
- 5.3 This Application for Enlistment is not transferable.
- 5.4 The language for submission of Application for Enlistment shall be English.
- 5.5 The person signing the application and submitting it on behalf of the Applicant shall enclose Power of Attorney duly authorized and notarized for the same. The Power of Attorney shall be backed by copy of the Board Resolution of Company.
- 5.6 After issuance of IFB/ NIT, Employer shall issue a communication separately to prospective bidders, who have been considered qualified meeting similar Technical QR in another tender in the past, stating that while submitting their bid, they are not required to submit the details/ documents pertaining to reference plants/ works/ past experiences in support of meeting Technical QR to the extent mentioned in the communication.

Such bidder shall be required to declare in Attachment-2A (Attachment seeking Bidder's Technical Qualification Detail) that they have received communication from the Employer and are not required to submit details/ documents pertaining to reference plants/ works/ past experiences for meeting Technical QR.

- 5.7 Bidders are required to furnish the details of the past experiences based on which selection is to be made as per format enclosed in the enlistment documents for the same. However, if

any of the reference work pertains to the Contract(s)/Works executed by Bidder for NTPC/NVVN in the past then in respect of such Contract(s)/Works Bidder shall not be required to enclose Client Certificate (s) along with its bid.

All the bidders, who are required to submit the details of the past experiences, shall submit all the documents, in support of Technical Qualification Requirements (such as copy of Purchase Orders/ Work Orders/ Contract Agreements/ Client Certificates/Certificate for successful operation etc.), duly certified and verified for authenticity from Independent Statutory Auditor of their Company or specified Third-Party Inspection Agency (TPIA).

Further, wherever information can be drawn from books of accounts, records and other relevant documents, Bidders can also submit a certificate issued by their Independent Statutory Auditor certifying the data required for meeting the Technical Qualification Requirements.

Such bidder shall be required to submit duly certified and verified documents from their Statutory Auditors or specified TPIA in support of meeting Technical QR along with a certificate regarding verification of authenticity of documents as per the format placed at Appendix D to Attachment-2A (Undertaking from Statutory Auditor) and/ or Appendix E to Attachment-2A (Undertaking from TPIA). All the documents submitted by the bidder in support of meeting Technical QR shall be digitally signed by the Statutory Auditor and/ or specified TPIA.

- 5.8 In case documents are certified & verified for authenticity through TPIA, the verification and certification of authenticity of documents is acceptable from any of the TPIAs as mentioned at NTPC tender website (<https://ntpctender.ntpc.co.in/>) under “Policy for Document Authentication Process in Tenders of NTPC Ltd” tab. However, Bidders must verify the accreditation validity of the designated TPIA before proceeding to engage them for document certification.

Any document pertaining to reference works/ plants in support of Technical QR, which is not certified by specified TPIA or Statutory Auditor of the bidder, as per the format enclosed with the bidding documents, shall not be considered verified/ certified for the purpose of evaluation, and the bid shall be liable for rejection.

- 5.9 Financial data should be given in Indian Rupees only. The Audited Balance sheet of the preceding three (03) years prior to the last date of submission of application for enlistment to be submitted.
- 5.10 The information furnished with the Application for Enlistment must be sufficient for processing and assessment.
- 5.11 The enclosed attachments shall be filled in completely and wherever not applicable it should be written as “Not Applicable”. Applicants should furnish the required information and desist from writing “shall be furnished later” or submitting the blank form.

- 5.12 In case the Applicant intends to give additional information for which specified space in the given attachment is not sufficient, it can be furnished by additional sheets.
- 5.13 All the pages of the Application for Enlistment and attachments should be signed and corrections and over writings should be countersigned by the authorized signatory.
- 5.14 Any information / data furnished by the applicant found to be incorrect or false or misleading at any point of time would render him liable to be debarred from the Enlistment / tendering / taking up of work in NVVN.
- 5.15 NVVN reserves the right to cross check and confirm the information / details furnished by the Applicant at any time during the period of enlistment.
- 5.16 Applicant shall give an undertaking at the time of Application for Enlistment that in case of award against any project specific enquiry, he shall register the awarded work with Safety Council of India (SCI), Mumbai and shall comply with requirements of SCI.
- 5.17 No Joint Venture or Consortium of firms shall be allowed to apply for the Enlistment. While filling the Application for Enlistment, the supporting documents should also be enclosed along with it and the applicant has to clearly confirm whether he is fully meeting all the parameters as per Clause 1.1.1 or 1.1.2 or 1.1.3 or 1.1.4 of Eligibility Criteria (Enclosed at Annexure I). In case the applicant is seeking Qualification as per Clause 1.1.4 of Eligibility Criteria, then in such case the applicant should be an Indian company registered in India and should be Group company/Holding Company/Subsidiary company of a firm meeting the requirement (s) of Clause 1.1.1 or 1.1.2 or 1.1.3 of Eligibility Criteria. Further, the applicant shall be required to furnish an Undertaking jointly executed by the firm qualified (as per clause 1.1.1 or 1.1.2 or 1.1.3 of Eligibility Criteria) and the applicant along with its Enlistment Application for complete performance of the contract (in case of award) jointly or severally, as per the format enclosed in the Enlistment document failing which the Applicant's Enlistment Application is liable to be rejected. If the applicant fails to submit an undertaking in the formats as mentioned above, his application shall be considered as incomplete and shall not be considered for Enlistment.

Bidder shall submit details along with documentary evidence of the experience details of his own or Group Company / Holding company Subsidiary company meeting the specified requirements as per Eligibility Criteria the time of submission of enlistment application.

- 5.18 The applicant should own sufficient construction equipment and other required equipment for the proper and timely execution of the work. The applicant should submit details of the same in the enclosed formats as sought in Attachment-3.
- 5.19 The applicant should have sufficient number of Technical and skilled manpower on its rolls for the proper execution of the Contract. The Applicant should submit details of the same in the enclosed formats as Attachment 2G.
- 5.20 Subsequent to enlistment, the enlisted bidders will be invited to submit the bids in respect of specific enquiry of NVVN for the Development /execution/ implementation Rooftop /Ground mounted Solar power Projects However, at the time of submission of bid in response to project specific enquiry for above Works, the bidder and his associate(s) may be assessed for the capacity and capability as per the Eligibility Criteria enclosed at Annexure-I.
- 5.21 The Applicant shall strictly adhere to the Fraud Prevention Policy of NVVN displayed on its tender website <http://www.nvvn.co.in> and shall immediately apprise the Employer i.e. NVVN about any fraud or suspected fraud as soon as it comes to their notice. (A certificate to this

effect shall be furnished by the applicant along with his application as per the format enclosed at **Attachment 6**).

## 6.0 SUBMISSION OF APPLICATIONS

The applicants are required to submit duly filled in and signed Application for Enlistment along with the relevant Documents/Certificates, duly uploaded on GePNIC Portal ([eprocurementpc.nic.in](http://eprocurementpc.nic.in)) on or before the last date and time for submission of applications as per schedule mentioned at GePNIC Portal

## 7.0 DEADLINES FOR SUBMISSION OF APPLICATIONS:

Applications must be submitted online no later than the time and date stated in the Schedule. NVVN shall not be liable for any delay and if any file gets corrupted.

NVVN may, at its discretion, extend this deadline for submission of applications by amending the Enlistment documents in accordance with **Clause 8.0**, in which case all rights and obligations of NVVN and Applicants will thereafter be subject to the deadline as extended.

## 8.0 AMENDMENT TO ENLISTMENT DOCUMENTS:

- a) At any time prior to the deadline for submission of Applications, NVVN may, for any reason, whether at its own initiative, or in response to a clarification requested by a prospective Bidder, amend the Enlistment documents.
- b) The amendments will be issued on e-procurement portal <https://eprocurementpc.nic.in>. The amendments will be binding on Bidders / Applicants, and it will be assumed that the information contained therein have been taken into account by the Bidder/Applicant in its Application. Applicants are also advised to regularly check the portal regarding posting of Amendment, if any.
- c) In order to afford prospective Bidders reasonable time in which to take the amendment into account in preparing their bid, NVVN may, at its discretion, extend the deadline for the submission of Applications.

## 9.0 OPENING OF APPLICATIONS:

- a) NVVN will open the Applications at the time, on the date and at the place specified in this Enlistment Document. In the event of the specified date for the opening of applications being declared a holiday for NVVN, the applications will be opened at the appointed time on the next working day. Applicant's attendance during the Application opening in NVVN Premises is not envisaged.
- b) Applications which are complete, complying and responsive to the requirements of the Enlistment Document will be considered for evaluation.

## 10.0 CLARIFICATIONS:

During the evaluation of the Applications, NVVN may, at its discretion, ask the Bidder / Applicant for a clarification of its application including documentary evidence pertaining to only the reference plants declared in the bid for the purpose of meeting Qualifying Requirement specified in the Enlistment Document. The request for clarification and the response shall be in writing and **no change in the substance of the application including**



**substitution of reference plants in the application by new/additional plant for conforming to Eligibility Criteria / Qualifying Requirement shall be sought, offered or permitted.**

**11.0 NOTIFICATION OF ENLISTMENT:**

NVVN will evaluate the applications in line with the requirements specified in this enlistment document. Upon meeting the Eligibility Criteria and other requirements of the enlistment documents, NVVN will notify the successful Applicants in writing by registered letter or by telefax to be confirmed in writing by registered letter that its application for enlistment for has been accepted the subject package.

**12.0 SCHEDULE:**

**13.0 EVALUATION CRITERIA FOR ENLISTMENT:**

- a) For the purpose of Enlistment, Applicants shall be evaluated on the basis of stipulated Eligibility Criteria along with supporting Documents/Certificates. The details of construction equipment owned, technical & skilled manpower employed, safety aspects etc. shall also be considered while assessing the capacity and capability of the Applicant.
- b) Even though an applicant may satisfy the above requirements, he would be liable to disqualification if he has made misleading or false representation or deliberately suppress the information in the forms, statements and enclosures required in the Application for Enlistment.

**14.0 CANCELLATION OF ENLISTED AGENCIES:**

- a) The Enlistment of agencies shall be cancelled by NVVN in case of their poor performance, abandoning of allotted work, delay in completion of work and handing over of fronts to other agencies, bankruptcy and activities detrimental to the interest of NVVN. The decision of NVVN in this regard shall be final and binding on the Contractor/Agency/Vendor.
- b) In case of change of name of the Enlisted Applicant without change of constitution/partners, the same shall be intimated along with proof of such change to NVVN immediately but in no case later than thirty (30) days from the date of such change occurs failing which the Enlistment of Agency/Contractor by that name shall be cancelled.

**15.0 PERIOD OF ENLISTMENT:**

This enlistment shall be valid for a period of ONE (1) year from the date of Enlistment with provision for further extension up to one year.

**16.0 RIGHT TO ACCEPT OR REJECT APPLICATION:**

Notwithstanding anything contained in this Application for Enlistment, NVVN reserves the right to accept or reject any Application and annul the process and reject all Applications at any time without any liability or any obligation for such acceptance, rejection or annulment without assigning any reasons.

**18.0 POLICY OF DEBARMENT OF BUSINESS DEALING:**

NVVN/NTPC has in place a Policy for Debarment of Business Dealings as displayed on its website <http://www.nvvn.co.in>. Business dealings may be withheld or banned with the Bidder/ Contractor on account of any of the grounds and following the procedures as detailed in the said Policy for Debarment of Business Dealings.

**19.0 CORRUPT OR FRAUDULENT PRACTICES:**

NVVN requires that Bidders / Applicants, Contractors and Suppliers observe the highest standard of ethics during the procurement and execution of the contracts. In pursuance of this policy, NVVN:

- (a) Defines, for the purposes of this provision, the terms set forth below as follows:
  - (i) "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
  - (ii) "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Employer and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Employer of the benefits of free and open competition.
- (b) will reject an application for enlistment if it determines that the Bidder/Applicant recommended for enlistment has engaged in corrupt or fraudulent practices.
- (c) will declare a firm ineligible, either indefinitely or for a stated period of time, for enlistment if it at any time determines that the firm has engaged in corrupt or fraudulent practices.

**20.0 FRAUD PREVENTION POLICY:**

The Bidder along with its associate / collaborator / subcontractors / sub-vendors / consultants / service providers shall strictly adhere to the Fraud Prevention Policy displayed on its website <http://www.nvvn.co.in> and shall immediately apprise the NVVN about any fraud or suspected fraud as soon as it comes to their notice. A Certificate to this effect shall be furnished by the bidder along with its Application in relevant attachment as per format enclosed in the Enlistment Documents.

**21.0 ISSUANCE OF ENQUIRY:**

After enlistment, whenever requirement emerges, based on the average annual Turnover, only those vendors having Turnover equal to, or more than Average Annual Turnover required shall be considered for the issuance of enquiry. Financial Documents submitted with the Enlistment Application shall be considered for calculating condition of average annual turnover for future issuance of enquiry, no change in financials shall be allowed during the tenure of the enlistment.

**Eligibility Criteria / Qualifying Requirements for Enlistment of EPC Bidders for Development of Rooftop and Ground Mounted Solar PV Power Projects Upto an Aggregate capacity of upto 20 MWp per vendor in one tender**

Applicant who wishes to participate in the enlistment shall satisfactorily establish that he fulfills the Eligibility Criteria (EC) / Qualifying Requirements (QR) stipulated hereunder:

In addition to the requirements stipulated under section Instruction to Bidder (ITB), the bidder should also meet the qualifying requirements stipulated hereunder in Clause 1.1 and Clause 1.2.

**1.1 TECHNICAL CRITERIA**

- 1.1.1 The Bidder should have designed/ engineered, supplied, erected/supervised erection and commissioned/ supervised commissioning of Solar Photo Voltaic (SPV) based grid connected power plant(s) of cumulative installed capacity of 400 kWp or higher, out of which at least one Solar Photo Voltaic plant should have been of 40 kWp or higher capacity.

The reference plant of 40 kWp or higher capacity must have been in successful operation for at least six (6) months prior to the last date of submission of application for enlistment.

**OR**

- 1.1.2 The Bidder should be a developer of Solar Photo Voltaic (SPV) based grid connected power plant(s) of cumulative installed capacity of 400 kWp or higher, out of which at least one Solar Photo Voltaic plant should have been of 40 kWp or higher capacity. The reference plant of 40 kWp or higher capacity must have been in successful operation for at least six (6) months prior to the last date of submission of application for enlistment.

**OR**

- 1.1.3 (a) The Bidder should have executed in the last ten (10) years an industrial project either as developer or as EPC Contractor in the area of power/ steel/oil and gas/ petro-chemical/ fertilizer/cement/coal mining including coal handling plant and/ or any other process industry, of a value of INR 40 Million (Indian Rupees Forty Million only) or more in a single project or single work respectively and the same should be in successful operation for at least one (1) year prior to Techno Commercial Bid Opening Date.

**AND**

- 1.1.3 (b) The Bidder should have executed at least one (1) Electrical Sub-station of 11 kV or above voltage level, consisting of equipment such as 11 kV or above voltage level circuit breakers and Power transformer, either as developer or as EPC Contractor which should be in successful operation for at least one (1) year prior to Techno Commercial Bid Opening Date.

The works referred to clause 1.1.3 (a) & 1.1.3 (b) can be in same or different projects.

**OR**

- 1.1.4 The bidder should be an Indian company registered in India and should be Group company/Holding Company/Subsidiary company of a firm meeting the requirement (s) of Clause 1.1.1 or 1.1.2 or 1.1.3 above.

In such a case, Bidder shall furnish an Undertaking jointly executed by the firm qualified as per clause 1.1.1 or 1.1.2 or 1.1.3 and the Bidder along with its Bid for complete performance of the contract (in case of award) jointly or severally, as per the format enclosed in the Bid document failing which the Bidder's Bid is liable to be rejected.

Notes for clause 1.1:

- a) The reference SPV based grid connected power plant of 40 kWp or higher capacity should be at a single location developed by Bidder for itself or any other client.
- b) Bidder shall submit certificate of successful completion and operation from the Owner.
