I. NTPC invites on-line bids on **Single Stage Two Envelope** Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders on **Open tender basis** for afore-mentioned package as per Scope of Work mentioned hereinafter.

### II. Brief Scope of Work:

Complete electrical operation & maintenance of PB substation along with HT Power supply to Sikri area electrical Systems which broadly includes 220KV, 132KV, 11KV, 33KV Switchyards, switchgears and circuits, all HT & LT MCCs, ACDB & DCDBs, Power transformers, LT oil filled Transformers, 220V,48V DC Batteries, chargers, LT Motors, Breakers, Cables, lighting, Air Conditioning units, Starter Panels of Drives, 11KV DG Sets, Fire Water Pump House, 33KV and 11KV Transmission Line, 33KV/415V Package substation etc.

Detailed Scope shall be as per Technical Specification / Terms of Reference.

- III. NTPC intends to finance the aforesaid Package through Own Resources.

- VII. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).
- VIII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the Gem Portal <a href="https://gem.gov.in">https://gem.gov.in</a>. The Bidder would be required to register on the website.

#### No Hard Copy of bidding documents shall be issued.

- IX. Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- **X.** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- **XI.** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- **XII.** Downloading / Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- **XIII.** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

#### **QUALIFYING REQUIREMENTS- (QR)**

#### 1.0 QUALIFYING REQUIREMENTS:

The bidders who wish to participate in the bidding process shall satisfactorily establish with documentary evidence that they fulfil the following Qualifying Requirements: -

#### 1.1 TECHNICAL CRITERIA

#### 1.1.1

- **A)** The bidder should have executed/completed the work of O&M **OR** Maintenance of Electrical systems of 220KV **or** above voltage class in a switchyard **OR** Substation in a power plant **OR** Other Industry within the preceding seven (07) years reckoned as on the date of Techno Commercial Bid Opening
- **B)** The bidder should have executed/completed the work of Maintenance of Transmission Lines of 33KV or above voltage class in a power plant **OR** Other Industry within the preceding seven (07) years reckoned as on the date of Techno Commercial Bid Opening

- **1.1.2** The bidder should have executed/completed Similar Works during the last seven (07) years, reckoned as on the date of Techno Commercial Bid Opening, having minimum order values as indicated below:
- a) Single (01) Work Order having Executed value not less than Rs. 73 Lakh.

#### OR

b) Two (02) Work Orders having Executed value not less than Rs. 46 Lakh each

#### OR

c) Three (03) Work Orders having Executed value not less than Rs. 37 Lakh each.

# Similar Work for Cl. 1.1.2 Means "O&M/ Maintenance works of Electrical Systems covering the areas of: -

- (a) Switchyard /Substation **OR**
- (b) Transmission Lines of 33KV or more voltage class **OR**
- (c) Transformers **OR**
- (d) HT/LT Systems/equipment **OR**
- (e) any combinations of (a), (b), (c), (d).

#### NOTES FOR TECHNICAL CRITERIA

- 1. The bidder should have achieved the criteria specified for Cl 1.1.1 A), Cl 1.1.1 B) through one composite work order OR separate work orders.
- 2. The word "executed/completed" means the bidder should have achieved the criteria specified in the technical criteria even if the total work order is not completed. In such cases where the work order is under execution, the executed period of said work order should be at least 06 (Six) months as on the date of Techno commercial Bid Opening, provided the execution period and executed value of work order till such date is certified by the Owner/ Project Authority.


- 3. Reference work executed by a Bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by Owner/Project Authority specifying the scope of work executed by the subcontractor in support of Qualifying Requirements.
- **4.** For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break –up of basic value and taxes.

#### 1.2 Financial Criteria:

- **1.2.1** The Average Annual Turnover of the Bidder should not be less than Rs. 92 Lakhs (Rupees Ninety-Two Lakhs only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- **1.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- **1.2.3** In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
  - a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
  - **b)** A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available

#### **Notes for Financial Criteria:**

- 1. Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- **3.** Net worth means the sum-total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- **4.** The requirement of Average Annual Turnover (AATO) for MSE- SC/ST & MSE-Women is not required. Evaluation for these bidders shall be carried out based on only technical criteria mentioned in the QR.
