1. Bidder has to mandatorily fill Annexure-12 (QR summary sheet). References as indicated in Annexure 1 2 (QR summary Sheet) shall only be considered to ascertain the bidder's compliance to Qualifying Requirement (QR).

2. Bidder may refer ITB (Instruction to bidder) clause 15.0 for Advisory Bank details for BG confirmations.

3. Bids not accompanied by requisite EMD as per clause 3.0 of SPC (Special Purchase Conditions) shall be outrightly rejected.

4. The bidder has to fill unit rates in the Excel price breakup sheet and attach the same along with PRICE BID only.
