1.0 NTPC invites online bids on **Single Stage Two Envelope Bidding Basis** for aforesaid Package, as per the Scope of Work mentioned hereinafter.

2.0 BRIEF SCOPE OF WORK

PMC/PEA shall be responsible for the entire scope of work for Project Management & Construction and successful commissioning of doubling of track from Kotarlia to Lara project and Augmentation of in-plant rail yard including OHE and S&T works and getting the work executed through the “contractors” engaged for and on behalf of Owner and successful commissioning of OHE and S&T System including Associated Electrical & Mechanical System Package for linking of track with existing MGR/ Railway Siding system of LARA. The scope of work also includes all testing and trial for commissioning of various sub-systems for MGR/ Railway Siding system as per terms & conditions specified in the bidding document/agreed between PMC/PEA and Owner. Any work within railway station premises is not included in the scope of work unless specifically mentioned otherwise.

3.0 NTPC intends to finance the subject package through Own Resources.

4.0 Dates for Bid Submission and Opening shall be as per the following schedule:

- 5.0** A complete set of Bidding Documents may be downloaded by any interested Bidder from the e-Tender Portal as per specified schedule. The tender is invited under e-tendering process. The bidders can enroll themselves on the website <https://eprocurentpc.nic.in/>. The use of Digital Signature Certificate (DSC) Class-3 key is mandatory for e-tendering activities. Accordingly, bidders should have Digital Signature Certificate (DSC) key of Class 3 to participate in e-tendering. Bidders, if required, can obtain DSC Class-3 key from agencies authorized by Govt. of India. The e-Tender Portal also has the user manuals with detailed guidelines on enrolment and participation in the bidding process.
- 6.0** NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no Bidder / intending Bidder shall have any claim arising out of such action.
- 7.0** Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."
- 8.0** Downloading/Issuance of Bidding Documents to any bidder shall not construe that such Bidder is considered to be qualified.
- 9.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
- Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.
- However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

You are requested to keep all the information confidential and do not disclose them to any other third party, persons or firms.
