#### 1.01 (a) Proven Experience

The Bidder should be the 'Original Equipment Manufacturer (OEM) of Siemens make Gas Turbine / manufacturer of Siemens make Gas Turbine **Blades** or its equivalent design & have already suppli ed at-least two (2) Sets of **Blades/ Vanes (Out of two sets minimum one set should be Blad es)** for Siemens make Gas Turbine or its equivalent design of minimum @100 MW ( in case of GE, MHI, Seimens, BHEL make Gas Turbines)/ @ 80 MW ( in case of ABB/Alstom make Gas Turbine) ISO rating, which should have satisfactorily completed one hot Gas Path Inspection or major overhaul ( minimum 15,000 EOH) prior to the techno-commercial bid opening date.

## 1.01 (b) Specific Plant related Technology and capability

Bidder must either himself possess or have access to the necessary technology for manufacturing of Blades of Siemens make Gas Turbine Model No. V 94.2 or its equivalent design applicable for Dad ri Gas Power Station having ISO rating of 142.42 MW at Turbine Inlet Temp (TIT) of **1060 Deg C.** 

The Bidder at his option can also outsource any of the activities required for manufacturing of abov e **Blades** subject to the condition that the chosen outsource agency by the bidder also has the nec essary technology for manufacturing of **Blades** of Siemens make Gas Turbine Model No. V 94.2 or i ts equivalent design applicable for Dadri Gas Power Station having ISO rating of 142.42 MW at Turbi ne Inlet Temp (TIT) of 1060 Deg C.

### 1.02 Route-2 [Meeting Criterion 1.02]

1.02 The Bidder can be licensee or Authorized Agent of Gas Turbine original equipment manufactur er (OEM) or its equivalent design. In such case, the bidder can be considered qualified based on the experience of the Principal who meets the requirements mentioned at para 1.01(a) **and** 1.01(b) ab ove.

#### Notes for 1.01 & 1.02:

NTPC has the right to assess the capability and capacity of the bidder for carrying out the manufact uring of required blades of V 94.2 machines of its Dadri plant in case of bidder meets the above qua lifying requirement through any route.

#### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs. 26.4 Cr (Rupees T wenty Six Crore & forty lakh only)** during the preceding three (3) completed financial years prio r to the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its ow n, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding fin ancial year is at least equal to or more than the paid-up share capital of the Holding Company. In s uch an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Lett er of Undertaking from the Holding Company, supported by Board Resolution, as per the format en closed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 1.2.3 Net worth of the Bidder should not be less than 100% (hundred percent) of its paid-up share c apital as on the last day of the preceding Financial year reckoned from the date of Techno-commer cial bid opening.

In case the Bidder does not meet the Net worth criteria on its own, it can meet the requirements of Net worth based on the strength of its Subsidiary (ies) and / or Holding Company and/or Subsidiarie s of the Holding Companies, wherever applicable. In such a case, however the Net worth of the Bidd er and its Subsidiary (ies) and/or Holding Company and/or Subsidiaries of the Holding Companies, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capital.

Net worth in combined manner shall be calculated as follows:

Net worth (combined)= [(X1+ X2 + X3) / (Y1 + Y2 + Y3)] X 100

Where X1, X2, X3 are individual Net worth which should not be less than 75% (Seventy-five percent age) of the respective paid-up share capitals and Y1, Y2, Y3 are individual paid up share capitals.

1.2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- 1.Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- 2.A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the biddin g documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 1.2.5 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered A ccountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three con secutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding

documents stating that the financial results of the Company are under audit as on the date of Tech no- Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 1.2:

- 1.Other income shall not be considered for arriving at annual turnover.
- 2."Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per C ompanies Act of India, in voque.
- 3.Net worth means the sum total of the paid up share capital and free reserves. Free reserve mean s all reserves credited out of the profits and share premium account but does not include reserves c redited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
