1.0 QUALIFYING REQUIREMENT (QR)

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated here under:

# 1.1 TECHNICAL CRITERIA

- 1.1.1 The Bidder should have Manufactured and Supplied during preceding seven (07) years prior to the date of techno-commercial bid opening:
- (a) At least one (1) km of 11 kV or above Voltage Rating XLPE Insulated Power cables

.

- b) At least one (1) km of Flame-retardant low smoke (FRLS) cables of any voltage grade.
- 1.1.2 The Bidder should have executed contract which includes Supply of 3.3 kV or above voltage rating P ower Cables, as per the following within the preceding seven (07) years prior to the date of techno-comme rcial bid opening:
  - A. Single (1) order having executed value not less than **Rs. 110 Lakhs**OR
  - B. Two (2) orders having executed value not less than **Rs. 69 Lakh each**OR
  - C. Three (3) orders having executed value not less than Rs. 55 Lakh each

#### **Notes for Technical Criteria:**

- 1. The word "Executed" mentioned above means that the bidder should have a chieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break up of basic value and taxes.
- 4. The bidder must submit Latest annual report OR NSIC / SSI / MSME registrati on certificate / BIS license /Type Test Report/ ISO certificate / Customer or 3<sup>rd</sup> proty Inspection report /any other statutory document as a proof of being manufacturer as per QR.

#### 1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs 138 Lakhs (Rupees One Hundred and Thirty-Eight Lakhs only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding fina ncial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnis h along with its Techno- Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclos ed in the bid documents, pledging unconditional and irrevocable financial s upport for the execution of the Contract by the bidder in case of award.
- 1.2.3 In case the bidder is not able to furnish its audited financial statem ents on stand- alone entity basis, the unaudited unconsolidated finan cial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiatio n of its qualification.
  - Copies of the unaudited unconsolidated financial statements of the bid der along with copies of the Audited consolidated financial statement s of its Holding Company.
  - A Certificate from the CEO/CFO of the Holding Company, as per the for mat enclosed in the bidding documents, stating that the unaudited un consolidated financial statements form part of the Consolidated Annu al Report of the company
- 1.2.4 In cases where audited results for the last preceding financial year

as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### Notes for 1.2:

- i. Other income shall not be considered for arriving at annual turnover.
- ii. "Holding Company" and "Subsidiary Company" shall have the meanin g ascribed to them as per Companies Act of India, in vogue.
- iii. Net worth means the sum total of the paid-up share capital and free re serves. Free reserve means all reserves credited out of the profits and s hare premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amal gamation. Further, any debit balance of Profit and Loss account and mis cellaneous expenses to the extent not adjusted or written off, if any, sh all be reduced from reserves and surplus.
- iv. MSE-SC/ST & MSE-Women bidders are exempted from meeting the av erage annual turnover (AATO) requirement of financial QR. Accordingly, for these bidders Evaluation shall be carried out only based on Technica I criteria of Qualification Requirements.
