



# INVITATION FOR EXPRESSION OF INTEREST (EOI)

Fresh Hiring of Transit Camp at Kota

### TERMS AND CONDITIONS FOR HIRING OF TRANSIT CAMP AT KOTA, RAJASTHAN

#### **SPECIFICATIONS FOR SPACE FOR TRANSIT CAMP:**

- 1. The property being offered should be situated preferably within appx. 5 Kilometer range from Kota Railway station.
- 2. The property being offered should have a space of 5-6 BHK (with attached toilets) and the built-up area requirement of approx. 4000 4500 Sq Ft. The property offered should preferably not exceed the first floor. In case the offered property comprises more than Ground plus One (G+1) floors, provision for a functional lift must be available.
- 3. In addition to the above, parking space for 3-4 vehicles should be available.
- 4. The lessor shall furnish the property offered at his own cost with the following furniture items/ electrical/electronic appliances:
  - a. Geyser and Exhaust Fan in all washrooms with western toilet.
  - b. All rooms to be equipped with ceiling fans, LED lights/tube lights and **01 fully automatic washing** machine.
  - c. 01 Kitchen with modular furniture, chimney, 01 microwave oven, 01 juicer mixer grinder, 01 RO system.
  - d. All windows must be provided with **new quality curtains along with curtain/blind fittings** of good quality.
  - e. The property should be equipped with an **inverter power backup system** capable of providing a **minimum backup (lights & fans) of 3-4 hours** for covering all bedrooms living rooms, Kitchen & dining area.
- 5. An NTPC representative may visit the property to assess its suitability.

#### **GENERAL TERMS AND CONDITIONS**

- 1. NTPC Limited requires space for Transit Camp on lease for a period of 36 months, which may be further extended for a period of another 12 months.
- 2. All Indian citizens/Companies may submit their offer. Brokers/estate agents can also apply; However, no brokerage shall be paid by NTPC Limited to the brokers submitting their offer.
- 3. The offers must be submitted in a sealed envelope containing **Two separate envelopes** each for technical bid and price bid. The envelopes must be superscribed with the following as applicable:
  - a. EOI for NTPC Transit Camp at Kota
- 4. Further, each of the above envelopes as applicable must contain technical details and Price bids in separate envelopes marked thereon with the technical specifications and Price bid. Failure to comply with this requirement will result in summary rejection of the offer.
- 5. The price Bid of will be opened only in those cases where, technical bid has been found suitable. For assessing the technical suitability, the authorized representatives of NTPC may undertake a visit / site inspection of the premises offered for lease rent.
- 6. NTPC Reserves its right to reject any offer without assigning any reason.
- 7. The property must have a clear title in the name of the person submitting the offer or a Power of Attorney in his name executed by the person having the clear title of the property.
- 8. NTPC Limited will reimburse the charges for the consumption of electricity and water to the Lessor as per bills received by him. However, payments will be made by the Lessor.
- 9. The Lessor shall pay all house taxes, rates, license fees, ground rent and charges of whatever character assessed, levied, charged, and imposed by or payable to any lawful authority in respect of the demised premises.
- 10. No society Maintenance charges shall be payable by the Lessee and Lessor shall pay such charges, if applicable.
- 11. Lessor shall affect all major repairs such as leakages, sanitary fittings, water pipes or cracks, etc. at his own cost immediately as and when such defects are notified to him by the Lessee. Minor repairs shall be carried out by the Lessee.
- 12. No major modifications shall be carried out by Lesse without approval from Lessor. However, Minor temporary/removable modifications as may be required shall be carried out by NTPC.
- 13. Lessee shall furnish the premises with Beds, Sofas, chairs etc. as per its requirement for which Lessor shall have no objection.
- 14. Lessor shall arrange the whitewash, distemper, paints, polish the demised premises before occupation by the Lessee and thereafter once in three years during the lease period or extended lease period, at his/her cost.
- 15. The Lessor shall quote Lease Rent on a Per Sq Ft basis which shall include all charges and amenities provided by the Lessor. The Final lease rent shall be calculated based on Carpet Area.
- 16. The lease shall not be terminable at the option of the Lessor before the expiry of the lease or extended lease period, except on breach of the terms and conditions by the Lessee but by giving 3 months advance notice.
- 17. The offeror shall submit proof of ownership along with their offer/quotation for Lease Rent.
- **18.** The monthly lease rent shall be fixed for the entire period of the lease and no escalation shall be claimed even for the extended period of up to 4 years.
- 19. The standard lease deed shall be executed by the Lessor and Lessee.
