## Part 1: General Information

### GENERAL DETAILS ABOUT NTPC SIPAT:

NTPC Sipat (2980 MW), a leading power generating unit of the largest power utility of India, NTPC Ltd, is located in the Bilaspur District of the state Chhattisgarh.

NTPC Sipat is at a distance of approximately 25 KM from Bilaspur Railway station and is well connected by road.

NTPC Sipat, generates approximately 50-60 Lakh MT of Ash annually as a byproduct of power generation. NTPC Sipat has 3 ash dykes for storing ash in ponds.

To utilize the pond ash in gainful and sustainable manner as per the provisions of extant MOEF&CC Gazette Notification and promote utilization of fly ash as resource material, NTPC SIPAT intends to issue some of its Pond Ash to interested agencies on free of cost and on first come first served basis (transportation cost to be borne by the bidders).

For this purpose, NTPC Sipat invites Expressions of Interest from interested agencies, for a period of 01 (One) year, from its ash dykes.

Further details regarding this Expression of Interest (Eoi) are as follow:

### EXPRESSION OF INTEREST:

NTPC Sipat invites Expression of Interest (EOI) for above, from interested Bidders, for utilization of Pond ash in avenues as identified in extant MOEF&CC Notification, in the prescribed formats (Part-2 & Part-3).

Total quantity of fly ash in MT from the Station, available for issue tentatively is as per details given hereunder -

### HOW TO APPLY

Interested Bidders desirous of receiving Pond ash from NTPC SIPAT as per the terms and conditions of this Eoi, may submit their Expression of Interest along with specified documents and duly filled in enclosed "Part 2: Format for Submission of Response to EOI" and "Part 3: Undertaking and Declaration by Bidder" to the E – Mail address [ausipat@ntpc.co.in](mailto:ausipat@ntpc.co.in) on or before **17:00 hrs. of 30th September 2025**. Alternatively, the documents can be submitted in hard copies to AUD office, First Floor Service Building Stage-I, NTPC Sipat Distt : Bilaspur (CG) 495555.

Documents to be submitted with duly filled "**Part 2 - Format for Submission of Response to EOI**" and "**Part 3: Undertaking and Declaration by Bidder**":

1. GST registration as may be applicable
2. Company registration as may be applicable

3. PAN Card copy
4. Power of Attorney for authorized person signing the EOI documents.
5. Business details of the participant / applicant as prescribed in Part 2 along with documentary proof as applicable.

All documents submitted shall be duly self-certified by the participant as being true and authentic. Interest / Offer / Bid is liable to be rejected if documentation is not complete.

### **ALLOCATION OF POND ASH QUANTITY:**

Based on the time of receipt of responses to EOI, Pond ash shall be allocated to various bidders free of cost and on first come first served basis, till the available offered quantity of **70 LMT** is exhausted. However, collecting from NTPC's issue location and transportation, thereafter, will be in the scope of the bidder only.

Daily allocation of Pond ash shall be done as given below:

1. All successful bidders shall submit a monthly requisition containing a list of their day wise requested quantities for each month by the 22nd of the previous month.
2. Based on above, corresponding annual allocated quantity and availability, NTPC shall determine and intimate the day wise allocation for each month by 28th of the previous month.
3. All allocated bidders (or transportation vendors) shall be expected to follow the above schedule and mobilize accordingly.
4. In case of non-mobilization / inadequate mobilization, NTPC may, at its discretion, allocate such quantity to alternate bidder(s) / avenue(s). Decision of Engineer in Charge (EIC)-NTPC shall be final and binding in this regard.

Pond ash shall be issued from the designated ash dykes as decided by the Engineer in charge (EIC) of the respective NTPC Station, on '**as is where is**' and "**first come first served**" basis.

### **REFUNDABLE SECURITY DEPOSIT (SD):**

Successful Bidder shall be required to submit Refundable Security Deposit amount along with submission of LOA / LOI acceptance after Evaluation of submitted requests and Ash Allocation Process, at the rate of Rs. 1.00 / **MT subject to minimum of Rs. 10,000**. This SD will be kept for ensuring commitment of the Successful Bidder(s) for lifting the allocated Ash. An amount at the rate of Rs. 1.00 / MT of un-lifted quantity will be forfeited.

This Security Deposit will be refundable after adjustment of amount to be recovered, if any. This adjusted SD amount will be refunded within 30 days of end of the contract period or of lifting of entire allocated quantity, whichever is earlier.

I / We agree to abide by the directions of the EIC (engineer in-charge) with regard to mobilization of adequate / commensurate number of healthy machinery and to operate them in a safe manner and also with regard to other aspects of the pond ash utilization including dyke safety. I / We agree to carry out the work as per instructions of, and to the full satisfaction of the EIC.

I / We agree to comply with all applicable statutory regulations including those regarding environmental, road transport etc. I / We shall fulfill all applicable statutory requirements for, and in connection with the execution of the contract.

I / We agree to cooperate with the EIC and with other agencies working in the area as directed by

the EIC with the objective of smooth and safe execution of lifting and utilization of pond ash.

I / We agree to submit indemnity bond indemnifying NTPC Ltd from any liability, whatsoever, which may arise due to violation / Non – compliance of any applicable norms / rules / regulations/ Guidelines / laws during the course of execution by way of omission or commission by the agency or its representatives / agents.

I / We hereby undertake to utilize the ash issued by NTPC for only the end use purposes as identified in extant MOEF & CC Notification. I/We also agree to submit on quarterly basis, an affidavit, on “Actual End Use” of the issued ash for the purposes as identified in extant MOEF & CC Notification.

I / We shall have no objection to the forfeiture of security deposit amount, in case I fail to execute the contract faithfully and the contract is terminated as per contract conditions.

I / We hereby also declare that all the particulars furnished by us in this EoI / Auction / Tender are true to the best of my/our knowledge and we understand and accept that if at any stage, the information furnished is found to be incorrect or false, we are liable for disqualification from this EoI / Auction / Tender and also are liable for any other penal action that may arise due to the above.

## Part 4: Terms and Conditions and General Guidelines:

1. Pond Ash shall be issued free of cost from any of the Ash Dykes of NTPC Sipat on as is where is basis as decided by EIC to the Successful Bidders (or their authorized representatives as may be agreed to in writing by the EIC), considering Availability, Operational and Safety issues.
2. Transportation and other related cost towards excavation, loading, unloading etc of Ash shall be in the Scope of the Bidder(s).
3. Bidders shall make themselves aware of the various extant rules and procedures related to Dyke Safety and Environmental/sustainability Guidelines of ash transportation and strictly adhere to during all activities of their work.
4. The transporters shall ensure full safety of the dykes while excavating, loading and transporting the ash from dykes. If transporter wishes to operate in the night, adequate lighting arrangement needs to be done by the transporter.
5. Transportation of pond ash shall be done in completely covered trucks by **200GSM Tarpaulin**. Any spill of ash, ash mixed water from the transporting vehicles shall be cleaned off by the transporter at his own cost.
6. Transporter's vehicles/drivers shall follow the prescribed speed limit, routes and other SOPs provided by EIC for the transportation. Repair and maintenance of the dyke road and other road enroute shall be in the scope of transporter as ash shall be issued on as is where is basis.
7. The deployment of the transporter in the loading area shall be strictly in line with suggested manpower list and responsibilities. The transporter shall abide by all the rules for transporting ash from NTPC Sipat's dykes.
8. No person / agency shall be allowed to lift ash without due and written permission from the EIC. Such cases shall be liable to prosecution as per legal proceedings. The transporting agency shall stick the labels bearing the name of agency in all the equipment and vehicles deployed for this work.
9. Bidders eligible for collecting Pond Ash shall apply for permission for the bulkers/covered trucks that they propose to deploy and submit the same to EIC along with specified documents like registration, license, insurance etc., who shall arrange to verify the same and issue permission/passes as per prevailing procedure adopted at the Station.
10. Depending upon operational convenience, safety etc. EIC can schedule or reschedule the lifting of ash by different agencies, which shall be binding upon the Bidders. Successful Bidders shall start collecting the Ash as per their respective allocation as per the schedule intimated by the EIC.
11. Statutory / regulatory compliances shall be binding upon all the Bidders and verifiable by TPP.
12. Non – compliance shall attract penal actions ranging from fine to termination of contract / agreement / issue of Pond ash as decided by EIC
13. Road Permits, Operator / Driver Licenses, Insurance etc. for the deployed Vehicles shall be submitted at the time of start of work (and also when new and / or additional vehicles are deployed) and thereafter as and when demanded by the EIC for verification. The vehicles

shall be in fit condition for safe operation.

14. Successful Bidders shall submit an affidavit on Non – judicial stamp paper of requisite value, certifying the complete Utilization of issued Pond ash, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
15. In case of any liability on NTPC Sipat, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Bidder or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Successful Bidder shall keep NTPC Sipat effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Ash.
16. NTPC reserves the right to take appropriate action as deemed fit, in case information/details provided by bidder in the EOI process are found false even at a later stages.
