Bidder may submit EMD (if applicable) in a sealed envelope separately offline along with other documents mentioned in the tender documents by the stipulated bid submission closing date and time at the address given below in accordance with the provisions set forth in the bidding documents, failing which, online bid shall be treated as nonresponsive and shall not be opened. ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY/EMD SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

#### V. Eligibility Condition for Participation:

- 1. NTPC enlisted vendors for the Contractor Enlistment ("Enlistment of vendors for Single Electrical Contract in NTPC Plant (Category-1)- CEG NO. EMD-10-Cat-1) with Average Annual Turn Over (AATO) & EC (Execution Capability) equal to or more than Rs.1,92,55,998/- can only participate in this tender. Bids received from other than enlisted bidders shall not be considered and the same shall be rejected. Bids received from enlisted bidders not meeting the above mentioned AATO and EC criteria shall be rejected during technical evaluation.
- 2. If non enlisted/rejected vendors are interested to participate, can do so in future tenders first by enlisting themselves for the respective product category (CEG). They shall have to visit NTPC CPC website https://vdc.ntpc.co.in and submit online application against items/services (Material /Contract Enlistment Groups) of their choice. If they meet the criteria stipulated in the Qualifying Requirement, they shall be enlisted in line with the Terms and Conditions of enlistment.
- 3. All participating vendors in this tender shall submit their latest enlistment certificate issued to them with mention of AATO & EC values for the item category (CEG) or submit any other proof of their enlistment in which AATO & EC along with CEG is mentioned. Else vendors may also attach the mail sent to them by the C&M /buyer department for participation in this specific tender."
- VA. Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN)

generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI).

- VI. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- VII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the Gem Portal https://gem.gov.in. The Bidder would be required to register on the website <a href="https://gem.gov.in">https://gem.gov.in</a>.

#### No Hard Copy of bidding documents shall be issued.

- **VIII.** Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified.
- **IX.** Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- X. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- XI. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
