1.0 NTPC Limited invites **online bids** on **Single Stage Two Envelope bidding basis (Envelope-I: Techno-Commercial Bid & Envelope-II: Price Bid)** from eligible bidders for aforesaid package, as per the Scope of Work briefly mentioned hereinafter.

2.0 BRIEF SCOPE OF WORK

Scope of Work: "The scope of work under this contract is to carry out the repair of interconnecting roads at various locations within the NTPC-NETRA campus by bituminous carpeting of 25 mm thickness and patch works."

3.0 NTPC intends to finance the subject package through Domestic/ Own Resources.

4.0 Detailed specification, scope of work and terms & conditions are given in the bidding documents, which are available at Government e-procurement portal of NIC (GePNIC) at website- [https://eprocurementpc.nic.in /](https://eprocurementpc.nic.in/) and as per the following schedule:

No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries/ Pre-Bid Conference (if applicable) as specified at GePNIC portal of NTPC.

- 5.0 All bids must be accompanied by Bid security for an **amount of Rs.1,00,000/- (Rupees One lakh only)** in the form as stipulated in Bidding Documents.

The Bid Security shall be submitted only through Electronic Fund Transfer (EFT) mode. The bidder shall upload proof of e-payment of Bid Security in the 'Fee Cover' of the Technical Bid on the e-tendering portal.

- 6.0 Acceptable Tender Fee payment proof shall be uploaded by all the bidder in the "Fee Cover" at the GePNIC Portal.

7.0 **Qualifying Requirements for Bidders:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

7.1.0 **Technical criteria:**

7.1.1. The Bidder should have successfully executed Bituminous Road construction works/ Bituminous Road repair works in India in preceding Seven (07) years as on the date of Techno-Commercial bid opening as per any of the following criteria:

a) One work of executed value not less than **Rs 51 Lakh**.

OR

b) Two works of executed value not less than **Rs 31 Lakh each**.

OR

c) Three works of executed value not less Rs **25 Lakh each**

Note for clause: 7.1.1 of QR:

- (i) The work "executed" mentioned above means the bidder should have achieved the criteria specified above, even if the total contract is not completed / closed.
- (ii) In case of orders which includes other items also are under execution, only the executed value of 'Bituminous Road construction works / Bituminous Road repair works' as certified by the Client shall be considered.
- (iii) The above value of executed Work(s) is exclusive of applicable tax/ GST.
- (iv) The reference works executed by the bidder's group company / subsidiary company/holding company shall not be considered for meeting the qualifying requirements by the bidder.

7.2.0 Financial Criteria:

7.2.1 The average annual turnover of the Bidder in the preceding three (3) financial years as on the date of techno-commercial bid opening should not be less than **Rs. 63.00 Lakh (Rupees Sixty-Three Lakh only)**.

7.2.2 While computing the annual turnover, other income shall not be considered.

7.2.3 In case, where audited results for the last financial year as on the date of Techno- commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable.

In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of techno commercial bid opening and the certificate from the practicing Chartered Account certifying the financial parameters is not available.

8.0 Notwithstanding anything stated above, NTPC reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators/associates/subsidiaries/group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer. The physical assessment shall include but not be limited to the assessment of office/facilities/banker's/reference workers by Employer. A negative

determination of such assessment of capacity and capabilities may result in rejection of the bid.

9.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

10.0 A complete set of Bidding Documents may be downloaded by any interested Bidder from the website <https://eprocurentpc.nic.in/>. The tender is invited under e-tendering process. The bidders can enroll themselves on the website <https://eprocurentpc.nic.in/> using the option "online Bidder Enrolment". The said website also has the detailed guidelines on enrollment and participation in the bidding process including Bidder Manual for online fee payment.

11.0 NTPC reserves right to amend any bid/tender conditions through appropriate CORRIGENDUMS published in the portal AT ANY TIME. NTPC also reserves the right to extend/change the bidding schedule through publishing necessary CORRIGENDUMS in the portal if the situation demands so AT ANY TIME. The corrigendum as decided by NTPC and deemed fit would be published in the portal as per provisions therein. This prevails over the relevant provisions elsewhere in the bid document. The corrigendum/amendment as published/posted in the portal will be binding on Bidders and it will be assumed that the information contained therein will have been taken into account by the Bidder in its bid. Bidders are advised to regularly check the tender regarding posting of Amendments/Corrigendum's, if any.

12.0 IMPORTANT NOTES:

a) **9.0 Attachment 3 - QR DATA SHEET** (ATTACHED separately for the package as bid document) is to be filled up properly for the stipulated QR parameters and to be submitted in the bid at appropriate file/folder provided for the purpose. **The reference works whose details have been declared in Attachment-3 AND/OR in the submitted bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR).**

b) LATEST PROVISIONS FOR "AUTHENTICATION OF VERACITY OF DOCUMENTS SUBMITTED BY THE BIDDER IN SUPPORT OF QUALIFYING REQUIREMENT" HAS BEEN INCORPORATED IN CLAUSE NO 6.1 OF BID DATA SHEET (SECTION III-BDS). AUTHENTICATED DOCUMENTS (AS APPLICABLE- FROM INDEPENDENT STATUTORY AUDITOR OF BIDDER/ OR SPECIFIED THIRD-PARTY INSPECTION AGENCY (TPIA)) IN LINE WITH THE SAID PROVISIONS TO BE COMPLIED.

c) **UDIN:** Any Certificate(s) / Financial Statement(s) / Audited Balance Sheet and P&L Account (wherever applicable) undertaken/ signed by a Member of Institute of Chartered Accountant of India (ICAI), which Bidders submit in support of compliance to Qualifying Requirements (QR), will carry Unique Document Identification Number (UDIN) generated in line with the Gazette Notification of Council of Institute of Chartered Accountant of India (ICAI). **It is mandatory to mention UDIN (Unique Document Identification Number) by the**

bidders while submitting audited financial statements, other CA certificates etc. w.e.f. date as mentioned in ICAI gazette notification dt. 02.08.2019.

d) The bid specific data for the package AS MENTIONED IN Bid Data Sheet (Section III- BDS) shall amend and/or supplement the provisions in the Instructions to Bidders (Section II- ITB). **Wherever there is a conflict, the provisions BDS shall prevail over those in the ITB.**

e) Special Conditions of Contract (SCC), Section-V, shall supplement/ amend the General Conditions of Contract (GCC) Section-IV of Standard Bidding Document, **wherever there is a conflict, the provisions in SCC shall prevail over those in the GCC of Standard Bidding Document.**

f) THIS IS A **NO DEVIATION TENDER**, WHICH MEANS - NO DEVIATION, WHATSOEVER, IS PERMITTED BY THE EMPLOYER TO ANY PROVISIONS OF BIDDING DOCUMENTS. GTE PROVISION IN THE BID SUBMISSION PROCESS IN TENDERING PLATFORM IS TO BE ACCEPTED FOR NO DEVIATION/ FULL COMPLIANCE TO THE BID DOCUMENTS. ACCEPTANCE TO THE SAID GTE WOULD CONFIRM THAT THE BIDDER HAVE ACCEPTED ALL THE TERMS AND CONDITIONS OF THE BID DOCUMENT.

13.0 Only **'Class-I local Bidders'** are eligible to participate in this tender bids submitted from Class II and Non local suppliers shall be outrightly rejected, bidder is requested to go through the guidelines as defined in the bidding documents/Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

14.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if the bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

15.0 Downloading/Issuance of Bidding Documents and /or submission of Bid shall not construe that such Bidder is considered to be qualified.

16.0 Transfer of Bidding Documents by one intending Bidder to another is not permissible.
