1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

**3. Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of GSTIN.

##### **Additional Terms and Conditions:**

1. Supply, transportation by rail/road up to **NTPC SIPAT** store/site, unloading and stacking is in the scope of supplier. Safety norms applicable at the plant to be followed strictly while stacking and unloading.
2. Damage/torn bag or frozen/set cement will not be accepted.
3. Cement shall be supplied in HDPE bags of capacity 50 kg each, conforming to **IS 11652: 1986**, bearing manufacture's name, week of manufacturing, and grade of cement.
4. Date of receipt of cement at site shall not be more than 2 weeks old from the date of manufacture.
5. Documents to be submitted:
  - i) Manufacturers Test Certificate against each week of manufacture as mentioned in the bag of cement.
  - ii) Delivery Challan/Invoice mentioning week of manufacture of cement.
6. The Manufacturers Test Certificate should indicate fineness, normal consistency, initial & final setting time, soundness, Total Alkali Content, compressive strength and any other test result as per tender specification.
7. Sampling & Testing:
  - i) After receiving of cement at **NTPC Sipat** Store/site, cement shall be tested at **NTPC Sipat Lab** for Fineness, setting time & Compressive strength as per **IS: 269 with latest amendment. The 28 days compressive strength of cement shall be minimum 43 N/mm<sup>2</sup>.**
  - ii) In case of cement fails to achieve the desired minimum 28 days compressive strength of **43 N/mm<sup>2</sup> as per IS 269 with latest amendment at NTPC Sipat Lab**, sampling of cement shall be made in presence of representatives from C&M/store department, FQA department and supplier for the supplied quantity of each week number. Afterwards, the sampled cement specimen shall be tested at **NTPC Approved Third Party Lab** for Fineness, setting time as per **IS: 269 with latest amendment and 28 days compressive strength of 43 N/mm<sup>2</sup> (minimum)**. The cost of the above testing including transportation charges shall be borne by the supplier.
  - iii) In case Cement fails to achieve the desired minimum 28 days compressive strength of **43 N/mm<sup>2</sup> (minimum), as per IS 269 with latest amendment**, supplier has to replace the total lot without any extra financial implication to NTPC. Lot means the total supplied quantity in particular week as printed on the bag of cement.
8. Vehicle deployed for transportation of cement shall have valid documents like valid national permits. Driver license, valid fitness certificate, PUC certificate etc. as per rules.

##### **QUALIFYING REQUIREMENTS FOR BIDDERS.**

The bidders who wish to participate in the bidding shall satisfactorily meet the Qualifying Requirements stipulated hereunder:

### **1.1 Technical Criteria:**

**1.1.1 The bidder should be manufacturer of OPC Cement and shall submit copy of valid BIS license(s) in support of the same.**

**1.1.2** The bidder should have the bidder should have supplied **OPC and/or PPC' Cement** within the preceding seven (07) years prior to the date of techno commercial bid opening, meeting the following criteria: -

A. Single executed order of cement quantity **not less than 4960 MT**

**OR**

B. Two executed orders of cement quantity **not less than 3100 MT in each order**

**OR**

C. Three executed orders of cement quantity **not less than 2480 MT in each order**

### **Notes for Technical Criteria:**

- i. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above within preceding seven (07) years reckoned from the date of Techno- commercial bid opening even if the total contract is started earlier and/or is not completed/closed.
- ii. In case of orders under execution, the Quantity of cement supply order executed prior to the date of Techno Commercial bid opening duly certified by bidder's client shall be considered acceptable.

### **1.2 Financial Criteria:**

**1.2.1** The The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than **Rs. 270 Lakhs (Two Crore Seventy Lakhs only)**

**1.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 3.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 3.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

**1.2.3** In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:

- i)** Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

ii) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno- Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno- Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### **Notes for 1.2:**

1. Other income shall not be considered for arriving at annual turnover.
2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
4. MSE -SC/ST & MSE-Women bidders are exempted from meeting the Average Annual Turnover (AATO) requirement of financial QR. Accordingly, for these bidders Evaluation shall be carried out only based on Technical Criteria of Qualification Requirements.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
