as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 1. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.0 Qualifying Requirements (QR)

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

1.1 Technical Criteria:

- 1.1.1 The bidder should be a "Manufacturer or Authorized representative of Manufacturer" of 'oil filtration machine'.
- 1.1.2 The Bidder should have supplied minimum one number quoted make of 'Transformer Oil Filtration Machine' which should have been in operation for at least one year in preceding seven (07) years prior to the date of techno-commercial bid opening.
- 1.1.3 The bidder should have executed orders which should include supply of "Oil filtration / Oil conditioning/ oil purification /oil flushing & filtration/ oil flushing / Oil handling /Lub Oil", "system/plant/machine" as per the following within preceding seven (07) years prior to the date of techno-commercial bid opening:
- A. Single order having executed value not less than Rs. 101 Lakh

OR

B. Two (2) orders having executed value not less than Rs. 63 Lakh each

OR

C. Three (3) orders having executed value not less than Rs. 51 Lakh each

Notes for Technical Criteria:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed prior to the date of TechnoCommercial bid opening duly certified by bidder's client shall be considered accepta ble.
- 3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case of contract is inclusive of taxes, bidder should provide the break -up of basic value and taxes.
- 4. The Bidder must submit Latest Annual report OR NSIC / SSI / MSME registration certificat e / BIS license / Type Test report /ISO certificate / Customer or 3rd party Inspection Report/ any other statutory document as a proof of being manufacturer as per QR.
- 5. For authorized representative of the manufacturer, the credentials of both bidder as well as its principal will be considered qualified under QR evaluation of clause 1.1.2 & 1.1.3.
- 6. Authorized representative should be specifically authorized by the Manufacturer for participating in this bid.

1.2. FINANCIAL CRITERIA:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than Rs. 127 Lakhs (R upees One Hundred and Twenty-Seven lakhs only) during the preceding three (3) complete d financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover require

ments at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the l ast day of the preceding financial year is at least equal to or more than the paid-up share c apital of the Holding Company. In such an event, the bidder would be required to furnish al ong with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, su pported by Board Resolution, as per the format enclosed in the bid documents, pledging un conditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

- 1.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be consid ered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder alo ng with copies of the Audited consolidated financial statements of its Holding Company.
 - A Certificate from the CEO/CFO of the Holding Company, as per the format en closed in the bidding documents, stating that the unaudited unconsolidated fi nancial statements form part of the Consolidated Annual Report of the compa ny.
- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practic ing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to sub mit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 1.2:

- 1.Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 3.Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not in clude reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscella neous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 4. MSE -SC/ST & MSE-Women bidders are exempted from meeting the Average Annual Turn over (AATO) requirement of financial QR. Accordingly, for these bidders Evaluation shall be carried out only based on Technical Criteria of Qualification Requirements."

Bidders may kindly note the Points mentioned below and submit the Offer accordingly:

- 1. Being a material procurement case MSE benefit shall be applicable for MSE bidders who are manufacturer of the quoted products only.
- 2. Bidders opting for submission of EMD in form of BG, shall ensure:-To submit EMD BG with sufficient validity period (165 days from date of Bid Opening) as mentioned in ATC with for mat strictly as suggested in the ATC document of the tender, deviation may lead to rejectio

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
