1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. Bidders also have to submit their offer for APCPL, Jhajjar (6 nos.)

- 1) Bidders shall upload FOR rate inclusive of GST in Price Bid Envelope as per attached format "Price Bid APCPL.xls". Bidders shall upload "Price Bid APCPL" after quoting for APCPL, Jhajjar as part of "Financial Document upload" in pdf format.
- 2) If no attachment is uploaded in Price bid envelope (To be uploaded in pdf format), it shall be deemed that the bidder has not submitted offer for APCPL, Jhajjar.
- 3) Evaluation and L1 Rate/vendor determination shall be done as per criteria stipulated in the bidding documents.
- 4) GeM Contract shall not be issued. However, Purchase order shall be issued separately by APCPL, Jhajjar.
- 5) Payment shall be released within 30 days of receipt and acceptance of material at site.
- 6) Vendors shall co-ordinate with APCPL, Jhajjar for all Post Purchase order activities.

Note : The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security included in the Employer's Bidding Documents only. Notes for 1.1:

1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
2. Authorized dealer of a manufacturer, having tender Specific authorization from a
manufacturer who meets the Qualifying Requirements stipulated in criteria 1.1.1(a)
can also participate. In such case, the bidder can furnish their own documents or
documents of manufacturer/ principal against QR criteria 1.1.2 as documentary proof for qualifying requirement.
3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break - up of basic value and taxes.

1.2.4	<p>In cases where audited results for the last preceding financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.</p>

Notes for 1.2 :

1. Other income shall not be considered for arriving at annual turnover.
2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
4. "MSE -SC/ST & MSE-Women bidders are exempted from meeting the Average Annual Turnover (AATO) requirement of financial QR. Accordingly, for these bidders Evaluation shall be carried out only based on Technical Criteria of Qualification Requirements."
