Bangladesh-India Friendship Power Company (Pvt.) Limited ("BIFPCL"), acting as the Employer, invites sealed Tenders from eligible bidders for "Procurement of Raw Materials (EN, CS, Brass, Copper & Bronze) for Workshop FOR 2x660 MW, MSTPP, RAMPAL, BAGERHAT" Project ("2x660 MW Maitree STPP" or "MSTPP") (the "Project") at Rampal, following Single Stage Two Envelope bidding procedure (Envelope-1: Technical Proposal and Envelope-2: Financial Proposal), as per the Scope of Work mentioned in brief hereinafter.

2.0 Brief Scope of Work

The Contractor shall commence supply Raw Materials(EN, CS, Brass, Copper & Bronze for Workshop FOR 2x660 MW, MSTPP, RAMPAL, BAGERHATagainst the subject package as per the 'Schedule of Requirement', considering the specifications/ conditions stipulated in the Bidding Documents. Installation of all the AC units as per BOQ/ 'Schedule of Requirement' shall be completed within the time period stipulated in the contract. Bidder is requested to go through the complete specification for the detailed scope of work, which is described in this Section of the Bidding Document, towards ensuring smooth and trouble-free operation of all activities in supply chain required for ensuring material delivery at site.

The detailed Scope of Work is provided in the Technical Specification (Section-VII) of the Bidding Document. Bidder shall consider the Bidding Document in its entirety for complete understanding and interpretation of the Scope of Work and Services and shall submit a Proposal that meets the complete requirement of the Bidding Document.

4.0 All bids must be accompanied by valid Bid Security strictly in the format as prescribed in ITT Clause#31, 32 & 33 and corresponding TDS clauses for an amount of BDT 7,60,000 (BDT Seven Lakh and Sixty Thousand only). Tender Security shall be submitted by the Bidder in original as in the form of either 'Demand Draft', 'Pay Order', 'Online bank transfer to the account of BIFPCL (Account details is given in Annexure-Y)' or an irrevocable and unconditional Bank Guarantee, strictly in the format and guidelines as specified under ITT Clause# 31, 32 & 33 of the tender document. Bid security/ Tender must be issued in favour of full name of Employer only, i.e. "Bangladesh-India Friendship Power Company Pvt. Ltd." In case of online transfer transactions details print out should be attached as EMD.

Any bid security/EMD issued in favour of short form of Employer (i.e. BIFPCL) or any official, e.g. Managing Director/ Chief Procurement Officer etc. shall be liable for rejection.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY SHALL BE REJECTED BY BIFPCL BEING TREATED AS NON-RESPONSIVE.


5.0 Qualifying Requirements for Bidder

- 5.1 Technical Criteria: Tenderers shall have the following minimum level of experience to qualify for the performance of the supplies under the contract:
- 5.1.1 Tenderers shall have the following minimum level of experience to qualify for the performance of the Supplies under the Contract:

The bidder must be a Manufacturer of Ferrous or, Non-Ferrous bars/rods with forging facility or The bidder must be an authorized representative who has experience in manufacturing/supplying Ferrous or, Non-Ferrous bars/rods and The bidder must have individually executed manufacturing / supplying of Ferrous or, Non-Ferrous bars/rods to any Govt. /Semi Govt. / Private Firm / Industry as on the date of techno-commercial bid opening, of value not less than

- a. BDT 3.00 Cr in a single contract (equivalent to USD 245,901 for vendors outside of Bangladesh) or
- b. BDT 2.25 Cr each in at least two contracts (equivalent to USD 184,426 for vendors outside of Bangladesh) or
- BDT 1.50 Cr each in at least three contracts in the last five (05) financial years. (equivalent to USD 1,23,000 for vendors outside of Bangladesh)

Years need to be counted backward from the date of issuance of NIT



Note to Clause 5.1 (Technical Criteria):

- a) In support of and in order to establish the aforesaid experience as per Clause No. 5. 1.1, the bidder must submit the following documents:
 - ١. Tenderer has to submit all supporting credentials like PO/ WO / COA/ Experience certificates in support of technical criteria.
 - II. In case of Manufacturer's Authorized Dealer, the Bidder shall submit authorization from manufacturer for participation in the tender.
 - In case of Dealership for trading of Steel rods / bars etc., the dealership certificate must III. be submitted.

The word "supplied/ supplying" means the Tenderer should have achieved the criteria specified in the above QR within the preceding five (5) financial year period even if the contract has been started earlier and / or is not completed /closed.

5.2 Financial Criteria: Tenderer shall have the following minimum level of financial capacity to qualify for the performance of the Supply under the Tender.

The Average Annual Turnover of the Bidder, in the immediately preceding three financial years ending on (last financial year end date) should not be less than BDT 22.61 Cr. (equivalent to **USD 18,53,000** for vendors outside of Bangladesh)

Note to Clause 5.2.1 (Financial Criteria):

In support of and in order to establish the AAT as per Clause 2.1, the bidder shall submit the audited copy of 'Annual Financial Report/ Balance Sheet/Profit & Loss Statement' of relevant financial years.

- a) In cases where audited financial results for the immediately preceding financial years are not available, certification of the financial statements from a practicing Chartered Accountant shall also be considered acceptable. In case, the bidder is not able to submit the certificate from practicing Chartered Accountant certifying the financial results of the immediately preceding financial year, the audited financial results of preceding three consecutive financial years may be submitted and the same shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company for immediately preceding Financial years are under audit and the Certificate would be required from the practicing Chartered Accountant certifying the financial parameters is not available. Bidder must also submit the copy of income tax return for the relevant years.
- b) Other income of bidder shall not be considered for arriving at the annual turnover.

5.3 **General Notes for Qualifying Requirements:**

i. All relevant certificates/ authenticated documents in support of the Qualifying Requirements shall have to be submitted by the bidder along with its bid. All the certificates must be authenticated by the authorized signatory of the bidder. Without such certificates / authenticated document or where the certificate / authenticated document are found to be unsatisfactory by BIFPCL, the Bid may be considered as non-responsive.

- ii. In case the end user(s) does not issue certificate to the bidder, but issues the certificate directly only to BIFPCL based on a request by the bidder, such certificate shall also be considered as part and parcel of the bidder's submission, provided the bidder submits copy of such request letter (duly authenticated as above) along with its Technical Proposal.
- iii. BIFPCL reserves the right to reject the Bid of the bidder(s) and forfeit the Bid Security, where any certificate or document submitted or representation made in support of the Qualifying Requirements is found to be false/untrue or fake.
- iv. Further certified photocopies of latest documents related to Valid National Identification Card (NID), Updated Trade License, Tax Identification Number (TIN), Latest income Tax Return Certificate/Acknowledgement slip, BIN/VAT Registration Certificate and other documents needed to be disclosed by vendor or to be obtained/maintained/complied as per law of GOB from the prospective bidders.
 - 6.0 Notwithstanding anything stated above, BIFPCL reserves the right to assess the capabilities and capacity of the bidder and/or consortium partner(s) and/or Holding company and/or Subsidiary company and/or Joint Venture company and/or Subsidiary of Holding company and/or the Sub-vendors and/or Suppliers and/or Sub-contractors to perform the contract, should the circumstances warrant such assessment in the overall interest of BIFPCL.
 - **7.0** Notwithstanding any other provision of the Bidding Document, BIFPCL reserves the right to reject any or all bids or cancel / withdraw / modify the Invitation for Bid without assigning any reason whatsoever and in such case, no bidder/ prospective bidder shall have any claim arising out of such action.
 - **8.0** prospective bidders may download the Bidding Document from www.bifpcl.com, the website of BIFPCL; Prospective bidders are advised to keep visiting the below mentioned website for any amendment(s)/ clarification(s)/errata to the Bidding Document or any other information related to this Invitation for Bid, which shall be posted on the website.  - 8.1 Issuance of Bidding Document to any bidder shall not construe to mean that such a bidder is considered to be qualified.
 - 8.2 The transfer or sharing of the Bidding Document purchased or downloaded by one intending bidder to another is not permissible.
 - 8.3 A bidder shall only submit one Bid. A firm can participate only as on individual basis. No joint venture or consortium is allowed to participate in this tender.
 - 9.0 Bids shall be submitted and opened at the address given below in the presence of bidders' representatives, who so choose to attend.
