1. Bid reserved for Make In India products: Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India). Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products, However, eligible micro and small enterprises will be allowed to participate. However, the authorization letter from the Manufacturers should be tender specific and they have to stand guarantee for the quality of supplied material ordered on their authorized dealer. In case of award, authorized dealer has to supply material from same manufacturer only, along with supporting documents.

ii. In a tender, either the Authorized Dealer on behalf of the Principal/Manufacturer or Principal/Manufacturer if self can bid but both cannot bid simultaneously for the same item/product in the same tender. If an authorize d dealer submits bid on behalf of the Principal/Manufacturer, the same dealer shall not submit a bid on behalf of another Principal/Manufacturer in the same tender for the same item/product.
