- 1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.0 QUALIFYING REQUIREMENTS

1.0 Qualifying Requirements:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulat ed hereunder:

1.1: Technical Criteria:

- 1.1.1 The bidder should be a Manufacturer of Backhoe Loader or 'authorized Dealer / Distributor' of manufacturer for the same.
- 1.1.2 The bidder should have executed the order(s) for supply of Heavy Earth Moving Vehicle, durin g the preceding seven (07) years prior to date of Techno- commercial bid opening in any of the following manner:
- 1. Executed value not less than Rs. 257 Lakhs in a Single Contract.

OR

2. Executed value not less than Rs. 161 Lakhs in Two Contracts each.

OR

3. Executed value not less than Rs. 129 Lakhs in Three Contracts each.

NOTES:

- 1. The word "executed" means the bidder should have achieved the criterion specified in the Qualif ying Requirements, even if the Order is not completed/closed.
- 2. In case of order under execution as on date of techno commercial bid opening, the value of the order executed till such date will be considered provided the same is certified by the employer.
- 3. The dealer/distributor should be especially authorized by the manufacturer for participating in thi s bid.
- 4. For arriving at the executed value of order specified above, basic amount only shall be considere d. In case order is inclusive of taxes, bidder should provide the break up of basic value and taxes".
- 5. Heavy Earth Moving Vehicle means Wheel Loader and/or Pay Loader and/or Back- hoe loader and /or Mobile Crane and/or Truck mounted crane and/or rough terrain crane and/or Dozer and/or Telehandler and/or Tyre-Handler and/or Excavator and/or Motor Grader.
- 6. Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / ISO certificate /3r d party or customer Inspection certificate/ARAI Certificate/ any other statutory document as a proof of being manufacturer as per QR.

1.2 Financial Criteria:

- 1.2.1 The Average Annual Turnover of the Bidder, should not be less than **321 lakhs (Rupees Thr ee Crore Twenty-one Lakh only)** during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 1.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 1.2.1 above on its ow n, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 1.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding fin ancial year is at least equal to or more than the paid-up share capital of the Holding Company. In s uch an event, the bidder would be required to furnish along with its Techno- Commercial bid, a Lett er of Undertaking from the Holding Company, supported by Board Resolution, as per the format en

closed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

- 1.2.3 In case the bidder is not able to furnish its audited financial statements on stand- alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
 - (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the b idding documents, stating that the unaudited unconsolidated financial statements form par t of the Consolidated Annual Report of the company.
- 1.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-C ommercial bid opening are not available, the financial results certified by a practicing Chartered Ac countant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from p racticing Chartered Accountant certifying its financial parameters, the audited results of three cons ecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclo sed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 1.2:

- 1.Other income shall not be considered for arriving at annual turnover.
- 2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in voque.
- 3. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve mean s all reserves credited out of the profits and share premium account but does not include reserves c redited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
