1. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. - C) The vendor should have supplied at least 5,000 MT of biomass pellets in any continuous twelve (12) months (consecutive 365 days) in one or multiple contracts during the preceding three (3) financial years along with the current financial year as on the last date of Techno-commercial bid opening.

Minimum EMD amount (corresponding to minimum 20 TPD quantity to be quoted by a bidder) shall be Rs 20 lakh and it shall remain same for quantity quoted upto 40TPD. Afterwards, EMD amount will increase as per above table.

In case of any discrepancy between the required Earnest Money Deposit (EMD) for the quoted quantity and the actual EMD submitted by the bidder, the quantity considered for evaluation and allocation shall be the lesser of the quoted quantity or the quantity corresponding to the submitted EMD amount.

All bidders including Traders/Aggregators/ Consortium have to submit EMD. The exemption from submission of EMD is allowed only to MSE bidder who is a manufacturer of biomass pellets.

EMD exemption: Micro and Small Enterprises (MSEs) having UDYAM Registration, for goods produced and services rendered, shall be exempted from paying Earnest Money Deposit. Such registered bidders will have to submit UDYAM Registration Certificate (**containing code of Biomass pellets i.e. 38300**) only, as a proof of being MSE on GeM Portal. Other MSE certificate will not be considered as a proof of being MSE.

In case of Traders/Aggregators/ Consortium, MSE benefits shall not be extended.

- 4.0 **Procurement price:** Biomass pellets benchmark price has been notified for NCR region by Ministry of Power vide letter No. F. No.11/86/2017-Th.11 (C.No:238797) dated 21.08.2025 .

The notified benchmark price for NCR is Rs. 2.32/1000 kcal (excluding GST) or 2.436 Rs/1000 kcal (including GST) @3400 Kcal. GST shall be paid as per extant rates, and will change if the rates of GST are changed.

Total procurement price shall be (A+B) as follows:

**A** i.e. Ex factory Price for non-torrefied Biomass {Rs. 2.436 Rs/1000Kcal or Rs 8282.40 / MT @3400 Kcal as notified by GoI including GST @5%} +

**B** i.e. Transportation price (to be quoted by Bidder) including GST in Rs/Ton for GCV 3400 Kcal/KG.

Note: 1) The bidders are required to fill the quantity in MT per day in the BOQ/Excel sheet. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
