### **Expression of Interest for Demonstration and Deployment of on premise 5G Non-Public Captive Network (CNPN) and its application**

- 1.0 NTPC is India's largest power utility with installed capacity of more than 85,000 MW (including its JVs). The company is engaged in the business of generation and sale of bulk power. NTPC is having pan-India presence with coal based, gas based, Hydro, Wind and Solar plants.
- 2.0 The evolution to fifth generation (5G) mobile networks marks a transformative era in telecommunications, offering remarkable enhancements in data transfer speeds, reduced latency, and the capability to support an extensive number of connected devices. Telecom Regulatory Authority of India (TRAI) is promoting Captive Non-Public Networks (CNPNs) to facilitate the digitization of key sectors.
- 3.0 NTPC is also looking for deployment of on-premises private 5G captive Non-Public network (CNPN) for power plants and is exploring 5G CNPN intensive use cases for formulating the 5G applications for power plant areas such as safety, surveillance, logistics and IOT device integration (Process parameters like pressure, temperature, vibration etc.).
- 4.0 The present EOI is for the installation of CNPN using 5G technology which offers significant potential benefits, including real-time monitoring and control, reliable high-speed, and low-latency communication networks, enhanced operational efficiency and robust cybersecurity frameworks to support modern power plant operations.
- 5.0 NTPC invites Expression of Interest (EOI) from willing APPLICANTs from India for installation of On-Premise 5G network alongwith applications such as:
  - a. Safety Application(smart helmets etc)
  - b. IoT-based monitoring
  - c. Mobile Handset
  - d. Intercom
  - e. Vehicle Smart Tag
  - f. Logistics (Supply chain monitoring)
  - g. Camera on Demand
  - h. Geo Fencing
  - i. Automation solutions or any other similar application in Thermal Power Plants.
  - j.
- 5.1 For the complete scheme Network cyber security to be applied. Successful Case studies to be provided for above showing the coverage area of the 5G CNPN network. Applicants to provide details of previous work orders in deployment of On-premise 5G network (CNPN) with successful running years.

5.2 Based on the details provided by the applicants, criteria for technical evaluation and shortlisting of applicants for on premise 5G network (as POC) based on use cases shall be decided. Based on technical evaluation and successful case studies, NTPC shall decide the modalities for engagement of vendor for the POC work.

## 6.0 Eligibility for Participation in EOI

- The APPLICANT shall be a Company / Sole Proprietorship / Partnership / Limited Liability Partnership / Consortium / Cooperative Society registered in India. The vendor should have valid UL License with the provision of CNPN.
- The APPLICANT shall submit details of on premise 5G network deployment and its use cases/running applications preferably from power plant industry along with supporting documents, such as end user certificates, coverage area etc. for establishing successful performance of 5G deployment for the period from the date of application.

## **8.0 Validity of Responses :**

The APPLICANT shall submit the responses which shall remain valid up to three (3) months after the response Deadline ("Response Validity"). NTPC reserves the right to reject any response which does not meet the above-mentioned validity requirement.

NTPC may solicit the APPLICANT's consent for an extension of the period of validity of the response. The request and the response in this regard shall be in writing. In the event any APPLICANT refuses to extend its response validity as requested by NTPC, NTPC shall terminate processing of such APPLICANT's responses. An APPLICANT accepting NTPC request for validity extension shall not be permitted to modify its response.



## **SECTION-II: INFORMATION TO APPLICANTS**

## **1.0 General Information**

NTPC has a fleet of thermal power plants consisting of more than 85000 MW capacity (including JV's) and more than 20000 MW thermal capacity is under construction at various locations. Presently we have different systems in place like CLIMS (Contractors Labour Information Management System), CCTV systems for safety and surveillance, remote process parameters connected to control system etc. The goal of on premise 5G (CNPN) network deployment is to bring it all in the umbrella of 5G network with advance features like monitoring, surveillance and better connectivity building safer and more secure power plant. This shall help in monitoring, timely response, strengthen preparedness in event of any unforeseen scenarios.

## **2.0 Objective of EOI**

As part of our strategic initiatives to enhance connectivity solutions, NTPC is looking to conduct Proof of Concept (POC) at mutually agreed sites for on-premises 5G network deployment, where bidder's solution can be evaluated for its performance, scalability, and integration capabilities.

Deployment of onsite 5G network intends to monitor site in real time with use of on demand 5G camera, Labor movements with smart helmets, better connectivity with push to talk devices, handsets etc. to enhance security and surveillance at stations/projects.

The objective of this POC is to demonstrate the feasibility, efficiency, and operational advantages of onsite 5G network solutions in real-time environments and evaluation of the same for usage in NTPC power plant.
