**2.0 BRIEF SCOPE OF WORK**

The scope of work includes construction of ash slurry pedestals, hume pipe crossings for ash slurry pedestals , culverts for pipe crossing, road restoration, construction of diversion roads, removal of diversion roads, insert plates, disposal of earth at designated locations, backfilling and associated works for Stage-III of NTPC Sipat.

**Detailed scope of work has been specified in the bidding documents.**

**3.0** Employer intends to finance the subject package through a mix of Debt and equity.

its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

**11.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

**12.0** Issuance of Bidding Documents to any Bidder shall not construe that such Bidder is considered to be qualified.

**13.0** Transfer of Bidding Documents by one intending Bidder to another is not permissible.
