1. NTPC invites online bids on **Single Stage Two Envelope Bidding Basis** for aforesaid Package, as per the Scope of Work mentioned hereinafter.
2. A complete set of Bidding Documents may be downloaded by shortlisted Bidder from the website <https://gem.gov.in>. The tender is invited under e-tendering process.
3. This NIT is published on Open Tender basis. Bids of the Following consultants/firms will be eligible for opening in this tender:

Bidders/consultants who are already enlisted with NTPC for the work of “Environmental Impact Assessment (EIA) Studies of Coal/gas based Thermal Power Station” or NABET/QCI accredited EIA consultant organization for Thermal Sector-1(d) in Category-A having Valid Certificate of Accreditation as on scheduled date of submission of bid. Further, the Bidder/consultant shall ensure validity of certificate with NABET/QCI during the execution of contract.

Bids received from uninvited entities shall be treated as unsolicited and shall be outrightly rejected.

4. BRIEF SCOPE OF WORK

NTPC Limited plans to expand the capacity of:

Talcher Super Thermal Power Station (Talcher STPP) by adding two additional 800 MW units as part of Talcher STPP Stage-III.

The proposed project is located near Kaniha Village of Angul district in Odisha. The nearest railhead is Talcher Railway Station which is at a distance of 23 km (aerial) from the power plant. NH-55 is passing nearby the plant connecting to Talcher. The nearest Airport is Bhubaneswar which is about 121 Km (aerial) from the power plant and the nearest seaport Paradip is 190 Km (aerial) from the power plant.

The EIA study will be conducted through a NABET accredited consultant for 'Thermal Power Sector' as per MOEF&CC standard TOR & approved TOR covering all the disciplines of environment (Land Use, Water Use, Demography & Socio-economics, Geology, Soils, Sediments, Hydrology, Water Quality, Meteorology, Air Quality, Terrestrial Ecology, Aquatic Ecology and Noise) based on one season field monitoring as per EIA notification dated 14.09.2006. Draft EIA Report will be prepared on the basis of one season (non-monsoon) baseline data and proposed project approved Term of References (TOR) for conducting Public Hearing (PH).

The consultant will enable in presenting the findings of the EIA report before the Environmental Public Hearing Committee, OSPCB and Expert Appraisal Committee (EAC) of the MoEF&CC, and submit all clarifications/replies/study findings/technical queries etc. for obtaining Consent to Establish (CTE) from the OSPCB and Environment Clearance (EC) from MoEF&CC. The EIA Report shall be framed in accordance with the latest EIA Notification of MoEF&CC dated 14.09.2006 or later and its subsequent amendments as applicable.

The detailed scope of work shall be as per scope defined in the Vol-II, Terms of Reference (TOR) of Bidding Document.

5. NTPC intends to finance the subject package through a mix of debt and Equity.
6. Dates for Bid Submission and Opening shall be as per the schedule mentioned at the GeM portal. Tentative schedule follow as:

7. All bids must be accompanied by Bid Security for an amount of **INR 50,000/- (Rupees Fifty Thousand only)** as per the provision of Instructions to Bidder (ITB). Bid security should be through Electronic Fund Transfer only.

"ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. BIDDER SHALL SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY IN THE GeM PORTAL."

HOWEVER, MSEs* SHALL BE EXEMPTED FROM PAYING BID SECURITY.

**Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal as per MSMED Act 2006 for goods produced and services shall be eligible for MSE benefits.*

Applicable relevant MSME Certificate should be submitted online/offline before schedule bid submission end date & time.

It is advised that all the Prospective Bidders shall register and obtain Udyam Registration Certificate. It may be noted that w.e.f. 1st April 2022, Udyam Registration Certificate shall be only valid Certificate to avail the benefits as per Public Procurement Policy.

MSEs seeking exemption and benefits should enclose an attested/self-certified copy of registration certificate as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."
10. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
