Bids received from other than enlisted bidders shall not be considered and the same shall be rejected. Bids received from enlisted bidders not meeting the above mentioned AATO and EC criteria shall be rejected during technical evaluation.

The Bidder is required to quote Total Lumpsum Price (including GST) in GeM Bid considering the BOQ as per ATC / Technical Specifications. Apart from GEM PO, NTPC shall also issue SAP PO for facilitating the payment with item wise price breakup of the final price as per ATC / Technical Specifications.

**1. EMD**

Bidder has to upload scanned copy / proof of the EMD along with online bid.

**ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE.
