The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

1.0 Technical Criteria

Route 1 [Meeting Criteria 1.01 & 1.02]

OR

Route 2 [Meeting Criteria 1.03]

1.01 PROVEN EXPERIENCE

The Bidder should be the Original Equipment Manufacturer (OEM) of SIEMENS make Gas Turbine / Manufacturer of SIEMENS make Gas Turbine blades or Its equivalent design and should have already supplied at-least two (2) sets of Stage-I or Stage-II air cooled blades/vanes for SIEMENS make Gas Turbine or its equivalent design of minimum 100MW ISO rating.

At least one (1) set out of above two (2) sets of blades or vanes should have satisfactorily completed one Hot Gas Path Inspection Or Major Overhaul (minimum 15000 EOH) prior to the date of techno-commercial bid opening.

AND

1.02 SPECIFIC PLANT RELATED TECHNOLOGY AND CAPABILITY

The Bidder must either himself possess or have access to the necessary technology for manufacturing and coating of air cooled vanes of SIEMENS make Gas Turbine model No V94.2 or its equivalent design for Dadri Gas Power Station having ISO rating of 142.42 MW at TIT of 1060 deg C.

The bidder at his option can also outsource any of the activities required for manufacturing / coating of the above vanes subject to the condition that the chosen outsourcing agency by the bidder also has the necessary technology for manufacturing /coating of air cooled vanes of SIEMENS make Gas Turbine model no V94.2 or its equivalent design for Dadri Gas Power Station having ISO rating of 142.42 MW at TIT of 1060 deg C.

1.03 The bidder can be a “licensee or authorized agent of Gas Turbine Original Equipment Manufacturer (OEM) or its equivalent design”/ “licensee or authorized agent of Manufacturer of SIEMENS make Gas Turbine blades/vanes or its equivalent design”.

In such cases, the bidder can be considered qualified based on the experience of his principal who meets the requirement at Clause **1.01 and 1.02** mentioned above.

Notes for Technical Criteria

1)NTPC has the right to assess the capability & capacity of the bidder for carrying out the manufacturing and/or coating of the required air cooled vanes of machines of its Dadri plant.

2) The bidders have to submit the details available with them or with their outsourcing agency in support of qualifying requirement.

2.0 Financial Criteria:

2.1 The Average Annual Turnover of the Bidder, should not be less than Rs.2729 Lakh (Rupees Twenty-Seven Crore Twenty-Nine Lakh only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

2.2 The Net Worth of the bidder as on the last day of the preceding financial year (reckoned on the date of techno-commercial bid opening) should not be less than 100% of the Bidder's paid-up share capital. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary (ies) and/or Holding Company and/or Subsidiaries of its Holding companies wherever applicable, the Net worth of the Bidder and its subsidiary (ies) and/or Holding Company and/or subsidiary (ies) of the Holding Company, in combined manner should not be less than 100% of their total paid-up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

$$\text{Net worth (combined)} = (X1+X2+X3) / (Y1+Y2+Y3) \times 100$$

Where X1, X2, X3 are individual Net worth which should not be less than 75% of the respective paid-up share capitals and Y1, Y2, Y3 are individual paid up share capitals.

2.3 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

2.4 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

2.5 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for financial criteria

i) Other income shall not be considered for arriving at annual turnover.

ii) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

iii) Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
