If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1.0 QUALIFYING REQUIREMENTS :

## **1.0 Qualifying Requirements:**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

### **1. Technical Criteria: (For meeting requirement of "1.1(a) OR 1.1(b)" AND 1.2)**

**1.1(a)** The bidder should be a Boiler Manufacturer and should have supplied at least one (1) number of Boiler to any Thermal power plant having minimum unit size of 200 MW.

OR

**1.1(b)** The bidder should have supplied "Coal Burner(s) / Coal Nozzle Tip(s) / Coal compartment assemblies" to any Thermal power plant having minimum unit size of 200 MW.

**1.2** The Bidder should have Supplied "Coal Nozzle Tip(s) and / or Coal Burner(s) and / or Coal compartment assemblies and / or Mechanical spares of Boiler" within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner:

A) One (1) order having executed value not less than Rs. 82 Lakh.

**OR**

B) Two (2) orders having executed value not less than Rs. 51 Lakh each.

**OR**

C) Three (3) orders having executed value not less than Rs. 41 Lakh each.

### **Notes:**

1.The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.

2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.

3. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break-up of basic value and taxes.

## **2. Financial Criteria:**

2.1 The Average Annual Turnover (AATO) of the bidder, should not be less than **Rs. 102 Lakhs (Rupees One Crore and Two lakh only)** during preceding three (3) completed financial years as on the date of Techno-commercial bid opening.

2.2 In case a Bidder does not satisfy the financial criteria, stipulated at Cl.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl.2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its Techno-Commercial Bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

### **Notes for Financial Criteria:**

i. Other income shall not be considered for arriving at annual turnover.

ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.

iii. Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
