5	Technical Qualifying requirements	<p>The Applicant must have executed the maintenance work of Ash Disposal Pipelines of 250 NB or higher size including replacement of minimum length of 2 Kilometre in a single work order during last five year from the date of application.</p> <p style="text-align: center;">OR</p> <p>The Applicant must have executed the erection work of Ash Disposal Pipelines of 250 NB or higher size for a minimum length of 2 Kilometres in a single work order during last five year from the date of application.</p> <p><b>Note :</b>  Execution of following jobs in isolation shall not be treated as credential for the subject works:</p> <ol style="list-style-type: none"> <li>(i) Execution of Structural Fabrication only</li> <li>(ii) Civil Pedestal jobs for laying of ash pipe lines only</li> <li>(iii) Pipe line rotation job only.</li> </ol>

6	Additional Documents to be submitted	<p>In addition to the documents required in support of meeting Technical Qualifying Requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment:-</p> <ul style="list-style-type: none"> <li>i. Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/Final Deviation Statement from the concerned client in support of successful execution of work against each of the POs to be submitted.</li> <li>ii. Audited balance sheet including Profit &amp; Loss statement for the previous three completed financial years reckoned from the date of application. In case, the audited documents are not ready / available, then certified copy of financial statement by a registered practicing chartered accountant may be submitted.</li> <li>iii. NSIC / SSI / MSME registration certificate</li> <li>iv. PF and Service Tax registration certificate</li> <li>v. Any other documents in addition to the above which the applicant wants to submit.</li> </ul>
7	<b>NOTES:</b>	<p><b>1.0 Similar work means:</b>  Work of Ash Disposal Pipe Lines (MS/ Cast Basalt) including replacement / erection of ash disposal pipe line of minimum diameter of 250 NB during last five years from the date of application.</p> <p><b>2.0 Value means basic value of the PO. Where PO value is composite (i.e. including Service taxes etc.), the applicant has to give break-up of composite PO value mentioning basic value, taxes etc. Any separate re-imburement/ escalation shall also not be considered.</b></p>
