General Details about NTPC Nabinagar:

NTPC Nabinagar, located at Auranagabad Distt Bihar, having a total installed capacity of 1980 MW, is engaged in the business of generation and sale of bulk power.

To utilize the fly ash in gainful and sustainable manner as per the provisions of extant MOEF&CC Gazette Notification and promote utilization of fly ash as resource material, NTPC Nabinagar intends to issue some of its Pond Ash on free of cost to Road Projects / Flyover embankments / Dams / Mines / Shoreline Protection structures in coastal Districts / Low Lying (as per extant MoEF&CC Notification and policy). Transportation cost (to the extent requested by the interested Ash User – with the provision that agency requesting the least support shall be given higher preference) shall be borne by NTPC Nabinagar within limits and as per criteria set by extant Government Notification, Advisory and Policy. Preference shall be given to requests having minimum cost implication to NTPC for ash transportation.

To facilitate this, *A Notice is being served by NTPC Nabinagar*, in compliance with MoEF&CC Gazette Notification dated 31.12.2021 on Fly Ash Utilization to the agencies engaged in construction activities such as road laying, road and flyover embankments, shoreline protection structures in coastal districts and dams, Low Lying, Mine Owners for Mine backfilling and OB Mixing, within 300 kms radius, for a period of 01 (One) year, from its 3 X 660 MW Stage-1 units

Allocation of Pond Ash Quantity:

Based on the receipt of responses to this Notice, Pond Ash shall be allocated to various Ash Users for qualified projects, keeping in view minimum cost implication to NTPC for transportation of Pond Ash, till the available offered quantity is exhausted. Pond Ash shall be issued free of cost.

In case the same Ash User gets some allocation against the last Auction Process and / or EoI for free issue with transportation by Ash User and also against this Notice, then the Ash quantity allocated against this Notice shall be issued to that Ash User, only after the Ash User completes the lifting / drawl of the allocation against the Auction Process and / or EoI for free issue with transportation by Ash User as applicable.

Daily allocation of Pond Ash shall be finalized by EIC depending upon site specific conditions and availability of Pond Ash at the Station on that particular day. The Pond ash shall be delivered to designated site / location as indicated in the requisition through transporters appointed by NTPC for the purpose. Ash User shall ensure timely unloading of the Pond Ash at destination and release of vehicles in reasonable time.

Part 4: Terms and Conditions and General Guidelines:

1. Pond Ash shall be issued from the designated area of Ash Dyke(s) / Pond(s) or other location as decided by EIC to the Ash Users (or their authorized representatives as may be agreed to in writing by the EIC), considering Operational and Safety issues of Ash dyke.
2. Statutory / regulatory compliances shall be binding upon all the Ash Users and verifiable by TPP.
3. Interested Ash User shall make themselves aware of the various extant Rules, Procedures, Safety norms, Environmental and Sustainability Guidelines etc and carry out their activities in full compliance with the same.
4. No person / agency shall be allowed to lift ash without due permission from TPP.
5. Depending upon operational convenience, safety, etc. EIC can schedule the lifting of Ash from Designated storage area by different agencies, which shall be binding upon the agencies. The schedules and deployment may be worked out / altered based on periodic meetings between concerned stakeholders.
6. On allocation of Pond Ash against this Notice, Successful Ash Users shall submit affidavit on Non – judicial stamp paper of requisite value, certifying the complete Utilization of issued Pond Ash, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
7. In case of any liability on TPP, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the Ash User or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Ash User shall keep TPP effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Pond Ash.
8. Interested and eligible Ash Users executing Project shall have to submit tentative time schedule of the project along with Request.
9. Interested and eligible Ash User shall have to submit End User Certificate for utilization of supplied Pond Ash.
10. All Eligible Projects shall source Pond Ash from Thermal Power Plants (TPPs) closest to their Project. Allocation of Pond Ash by TPP shall be in compliance with the same.
11. It shall also be the responsibility of the Ash User(s) to ensure that the Ash sent from the TPP is facilitated for quick unloading and release of vehicle.

12. NTPC reserves its right to take appropriate action as deemed fit, in case information / details provided are found false even at a later date.
