



**Annual Maintenance Contract for NSPCL SAP ERP system for 3 years**

**A. Introduction**

1. NTPC SAIL Power Company Ltd. (NSPCL) is currently running ERP system based on SAP installed at Data Centre at BSNL, Faridabad and Disaster Recovery Centre at BSNL, Ahmedabad.
2. NSPCL had placed contract for supply of SAP ERP licenses, implementation & support of SAP ERP system at NSPCL to system Integrator (SI) in Aug 2013. The System Integrator (SI) had supplied, installed and implemented SAP ERP system in NSPCL. SI has also maintained the implemented system after the stabilization till date.
3. Currently NSPCL have 1175 total Z developments, 432 SAP user licenses & 573 ESS user licences.
4. SAP modules of Finance and Controlling (FICO), Material Management (MM), Human Resources (HCM) and Payroll, Plant Maintenance (PM), Operation, Quality Management (QM), Project System (PS) and Document Management System (DMS), Supplier Relations Management (SRM) of Public Procurement System and Business analytics (BI) have been implemented at all locations of NSPCL.
5. For smooth functioning of SAP/ERP system, support of ERP system is required through consultants team provided by Service Provider, to be deployed partially at NSPCL Corporate office and remotely. Through this AMC, the consultant team of Service Provider shall carry out the required support / functions / activities.
