

TECHNICAL SPECIFICATION / TERMS OF REFERENCE / SCOPE OF SERVICE

PACKAGE NAME : HIRING OF EQUIPMENTS FOR HANDLING AND REHANDLING OF COAL FOR KERENDARI COAL MINING PROJECT

Scope of Service / Scope of Work:

- 1) Deployment of following equipment's along with manpower/operator for 08 months, as per direction of EIC
 - Excavator (Minimum capacity 1 Cum) – 01No
 - Loader (Minimum capacity 3 Cum) - 01 No.
 - Tipping Truck (Minimum capacity 25 Ton) - 02 No.
 - Dozer (Minimum capacity 175 HP) - 01 No.
- 2) Movement of the above equipment's shall be withing the vicinity of KDCMP.
- 3) Equipment's shall be available as and when required and as per the direction of EIC to meet the NTPC requirement. Tipping truck must be hydraulically operated (including hydraulically operated tail gate).
- 4) Equipment's maintenance /required consumables /Fuel/spares shall be in bidder scope.
- 5) Machine must be robust enough to handle ROM coal of size 1200MM and shall be capable of continues operation.
- 6) Any type of work required for the successful operation of these equipment's shall be in bidder scope.
- 7) Suitable type and qty of Fire Extinguishers to be provided by the bidder inside each equipment's.
- 8) Bidder must ensure the availability of minimum required spares /consumables at all times.
- 9) Accommodation/storage and transportation of men and materials for the successful operation of the equipment is responsibility of the bidder.
- 10) Bidder has to make arrangement of water for equipment & drinking water required for the operator /staff at his own cost. The bidder has to provide all personal safety equipment's to its staff/operator and is responsible for the safety and security of

men/operator and equipment deployed. The bidder shall strictly follow / abide by NTPC safety rules and policy during the tenure of contract.

- 11) Bidder shall submit all the statutory documents like RC /PUC /Insurance /clearance certificate/fitness certificate etc of each equipment's and all other related documents from state authority as per RTO rules .
- 12) Deployment of above equipment's shall be ensured within 7 days from the date confirmation by NTPC.
- 13) Deployment of vehicle shall be for 16 Hrs/day. However equipment can be used either round the clock or as per NTPC requirement. If working hours exceed from 16 Hrs /day, Sufficient qualified operators shall be arranged/deployed by contractor to cater the NTPC requirement.
- 14) **Payment Terms:** Payment shall be processed on monthly RA bill basis on certification of EIC. Applicable taxes shall be reimbursed extra.
- 15) **Penalty:** In case of non operation of equipment/ no work on account of contractor's fault, penalty @per hour awarded rate shall be charged. This shall be applicable for the entire contract period.
- 16) Defect liability period and LD shall be NIL.
- 17) Escalation clause - Not applicable
- 18) Responsibility to maintain the equipment running log book and get it signed from NTPC authorized person is in the scope of bidder. The copy of log book of each equipment shall be submitted along with the monthly bill.
- 19) **Permissible deviation:** The variation shall be limited to as per GCC of the awarded value of the contract.
- 20) If the equipments are unable to be delivered as stipulated in the Scope, Terms and conditions, NTPC reserves the right to terminate the contract as per GCC.
- 21) **Price Basis:** FIRM
- 22) Amount linked to Safety Aspects / compliance to Safety Rules shall be 5% of total contract value or the quoted Amount by the Bidder, whichever is higher.
- 23) **Contract Period:** The contract period of this work shall be 8 months from the stipulated date of start of the contract with provision of 1 month extension at the same terms and condition, as per direction of EIC. The start date of Contract shall be tentatively in July'2024, which is subject to change as per discretion of NTPC.

OTHER TERMS AND CONDITION OF THE CONTRACT.

- i. Security Deposit shall be deducted from all the RA bills.as per GCC
- ii. No interest will be payable on the earnest money of Security deposit or any other amount which shall become payable to the contractor under this contract.
- iii. TDS shall be deducted as per applicable laws.
- iv. Payment Mode: Through EFT
- v. Agency must execute contract agreement with NTPC within 30 days from the issue of Purchase Order (PO) on appropriate value of stamp paper.
- vi. EIC – AGM/DGM, Coal Dispatch & Billing / Nominated representative of KDCMP
